**FILM REVIEW**

Jockey RAFAEL BEJARANO came to the office to review his ride in the last race yesterday. His mount drifted out during the stretch run and caused two horses to steady. He explained that his horse had an extremely sensitive mouth and he was therefore afraid to use the reins too much. We explained that he would have to find a way to control his mount. Fortunately he was clear of the two horses that steadied and received a warning.

Jockey JAMES GRAHAM came to the office to review his crop use during two races yesterday. In the seventh, we wanted to review his flagging style to the extent that his flagging looks very similar to a strike. We asked that he be a little more clear with respect to whether he was whipping or flagging both from a stewarding standpoint, as well as a perception standpoint. We also reviewed the third race. Although Mr. Graham was initially skeptical about whether he had struck his mount four times in succession, the video made that fact clear. We therefore issued the following ruling:

**DMTD Ruling #026**

Jockey JAMES GRAHAM is fined THREE HUNDRED DOLLARS (\$300.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – second offense), during the third race at Del Mar Race Track on July 25, 2015.

Jockey BRICE BLANC called yesterday in lieu of his hearing this morning. He examined his ride in the first race and acknowledged that he violated the crop rule. He

explained that his mount was pulling up, but also acknowledged that this was not an excuse to use his crop more than three times in succession. We issued the following ruling:

DMTD Ruling #024

Jockey BRICE BLANC is fined TWO HUNDRED DOLLARS (\$200.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense), during the first race at Del Mar Race Track on July 25, 2015.

Jockey COREY NAKATANI came to the office to review his ride in the seventh race. He struck his mount four times in succession. He didn't exactly seem clear about what the new rule required, so we explained the rule and issued the following ruling:

DMTD Ruling #025

Jockey COREY NAKATANI is fined TWO HUNDRED DOLLARS (\$200.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense), during the seventh race at Del Mar Race Track on July 25, 2015.

**PENA RULING**

Apprentice BRAYAN PENA jockey was issued the following ruling when he reported the incorrect weight on Friday:

Apprentice Jockey BRAYAN PENA is fined FIVE HUNDRED DOLLARS (\$500.00)\* for failure to report the proper riding weight for the third race at Del Mar Race Track on July 24, 2015. This constitutes a violation of California Horse Racing Board rule (Weighing Out).

**SANCHEZ RULING**

Pursuant to the formal hearing we held regarding pony rider JOSE SANCHEZ two months ago, we issued the following as well as a statement of decision:

Assistant trainer JOSE SANCHEZ is fined FIVE HUNDRED DOLLARS (\$500.00)\* for violation of California Horse Racing Board rule #1902.5 (Animal Welfare– creating a saddle sore and riding a lame horse).

**BROCKLEBANK RULING**

Pursuant to the formal medication hearing we held yesterday, we issued the following the ruling:

DMTD Ruling #027

Trainer JOHN BROCKLEBANK, who started the horse DUBDUBWATSON in the second race at Santa Anita Park on May 22, 2015 is fined FIVE HUNDRED DOLLARS (\$500.00)\* for violation of California Horse Racing Board rule #1843(a)(d) (Medications Drugs and Other substances – Isoflupredone – 220 pg/ml) pursuant to #1887 (Trainer to Insure Condition of Horse).

### **INQUIRY/NON-STARTER**

We posted the inquiry sign immediately after the start of the third race today to examine the start of #9 Admiral Jaxon. It was immediately obvious, and the video confirmed, that the starter opened the gates while the assistant starter was standing in front of #9. Fortunately, the horse did not break, rather walked out with the assistant starter, who then was able to get out of the way. After speaking with the starter, we declared the horse a nonstarter and made the appropriate refunds.

### **INQUIRY/NO CHANGE**

Following the running of the sixth race, we posted the inquiry sign to examine the start of #1 Kobe's Back. Films revealed that the horse caused its own problems by breaking in sharply. He was therefore declared a starter.

**FILM REVIEW**

Jockey KENT DESORMEAUX came to the office to review his ride in the third race yesterday. In angling out during the stretch run, we felt he could have done it a bit more smoothly. He agreed; no penalty. We also discussed the fact that he failed a breathalyzer test yesterday afternoon and was removed from his remaining mounts. We referred the matter to the investigative staff and explained that he would be permitted to ride in the interim provided that he submitted to a breathalyzer before each racing card.

Jockey CHRISTIAN ARAGON came to the office to review a ride from last week. We felt he didn't persevere to the wire while finishing sixth. He said that his horse was getting very tired. We explained that he should keep riding or pull his horse up. He agreed.

**CHEW HEARING**

We held a formal hearing this morning into case number 15LT003 which was a complaint filed by the CHRB against trainer MATT CHEW alleging a phenylbutazone

overage in one of his runners. The blood sample taken from "Go Jeremiah" after the third race at Santa Anita on June 20, 2015, showed the presence of 2.97ug/ml of bute. Given the amount and Mr. Chew's record, the CHRB asked for a warning. That request was granted.

### **PENDER RULING**

After reaching a settlement agreement with the CHRB regarding case number 14LT035, trainer MIKE PENDER agreed to the terms published in the ruling that follows. This case involved Mr. Pender continuing to bill his owners for training services while he was under suspension. **FILM REVIEW**

Jockey RAFAEL BEJARANO came to the office to review his ride in the fifth race yesterday. We felt he could have angled out more smoothly entering the stretch. He agreed. Warning.

Jockey FERNANDO PEREZ came to the office as directed to review his role in an incident going into the first turf elbow of the seventh race yesterday. While there were a few factors that created the traffic jam, we felt that Mr. Perez could have relieved some of the pressure from his position on the outside. He agreed. We also instructed the starter to place the starting gate further back and move the field one stall out when the track and chute are configured in this manner.

Jockey DRAYDEN VANDYKE came to the office to review his ride in the fifth race yesterday during which he struck his mount seven times in succession without giving the horse a chance to respond. We considered a stiffer than normal penalty because this was excessive but ultimately elected for the normal progression during the first few months of the new rule. We issued the following:

**INQUIRY/DISQUALIFICATION**

Following the running of the first race, we posted the inquiry sign in order to review and incident involving the first two finishers. Video showed the eventual winner #1 Minister'sadventure (F. Prat, jockey) angle out in the stretch bumping

and moving the second place finisher #4 An Unusual Group (J. Graham, jockey) out several times. After speaking with the patrol judges and the riders involved, we unanimously voted to disqualify the winner and place her second.

**INQUIRY/NO CHANGE**

Following the running of the seventh race, we posted the inquiry sign to examine the start of #11 Sambamzajammin (K. Desormeaux) who left the gate awkwardly and was pulled up by her rider. It appeared as if horse and rider were not ready or that the horse was in the process of acting up when the gates opened; but either way, video made it clear that the horse and rider caused their own trouble and therefore we made no change and declared #11 Sambamzajammin a starter.

**FILM REVIEW**

Jockey FLAVIEN PRAT came to the office to review his rides in the first and fifth races yesterday. In the fifth race his mount drifted out and brushed a rival. We cautioned him to keep a straighter course. He agreed. In the first race, his mount was disqualified for interference. While Mr. Prat felt that the sufferer of the interference was more to blame, we felt that he pushed his way out and was responsible for three points of contact. Therefore we issued the following ruling:

**DMTD Ruling #034**

Jockey FLAVIEN PRAT, who rode Minster's adventure in the first race at Del Mar Thoroughbred Club on July 31, 2015, is suspended for three (3) racing days (August 7, 8, and 9, 2015), for failure to make the proper effort to maintain a straight course in the stretch, causing interference which resulted in the disqualification of his mount from first to second position. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules - careless riding). Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

Jockey DRAYDEN VANDYKE came to the office to review his crop use in the fifth race yesterday. On two occasions, he used his riding crop four times in succession without giving his mount a chance to respond. We issued the following:

**DMTD Ruling #035**

Jockey DRAYDEN VAN DYKE is fined FIVE HUNDRED DOLLARS (\$500.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – third offense), during the fifth race at Del Mar Race Track on July 31, 2015.

Jockey COREY NAKATANI came to the office to review his use of the crop during the stretch run of the fifth race yesterday. He appeared to strike his horse four times in succession on the shoulder. Further review of the video indicated to the majority that one of the aforementioned strikes was actually a flag (Steward Sawyer, thought there were four successive strikes). Warning.

**INQUIRY/NO CHANGE/STARTER**

Following the running of the third race we posted the inquiry sign to examine the start (or lack thereof) of #4 Currency Exchange. Video revealed that the gates opened at the same time and that the assistant starter released the horse at the proper time, but that the horse simply walked out of the gate. Given that he caused his own difficulty, he was declared a starter.

**INQUIRY/OBJECTION/NO CHANGE/STARTER**

Following the running of the ninth race, we posted the inquiry sign and the objection sign. With respect to the inquiry, we examined the start of #4 Seeking the West (F. Perez, Jockey), who broke through the gate before the rest of the field. The horse eventually finished eighth. Given that the horse was responsible for the false start, we declared the horse a starter. With respect to the objection, jockey Santiago Gonzalez who finished second, claimed foul against the winner for interference at the quarter pole. Video revealed that the winner was not responsible for the fact that #7 Perfect Set was in tight quarters, and that Mr. Gonzalez rode his horse into a space without sufficient room. Therefore, we made no change to the original order of finish.
