A Jockey objection lodged by Jockey **Kyle Frey** (4TH) against the winner #5 **Splashing**. Involved were #1 **Springtime Dance** (**Kyle Frey** 4TH), #3 **Pulpitinthesky** (**Catalino Martinez** 2ND) and the #5 **Splashing** (**Irving Orozco** 1ST). Inside the 1/16 pole #3 **Pulpitinthesky** stepped out slightly as the #5 **Splashing** drifted in under a right-handed urging, causing the #1 **Springtime Dance** to steady. In the opinion of the stewards the incident did not cost #1 **Springtime Dance** a better placing.
