In the matter of:

Owner **JOHN JAY BROCKLEBANK**

Complaint #07BM148, filed by San Francisco Equine against owner John Jay Brocklebank, alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility) in the amount of \$244.00, is hereby dismissed with prejudice as the complaint erroneously named Mr. Brocklebank as the owner of the horse NEVADA WORRIER.

Further, Golden Gate Fields ruling #4, dated November 15, 2007, which suspended Mr. Brocklebank for violation of California Horse Racing Board rule #1547 (Failure to Appear), is set aside and the license privileges of Mr. Brocklebank are restored to good standing.

The above ruling was issued upon the acknowledgement that owner John Brocklebank was not the owner of record of the horse involved in Case #07BM148.

FILM REVIEW - RULING NO. 11

Jockey **SALOMON SALGUERO** appeared before the stewards to review the third race on November 21, 2007. Mr. Salguero was without excuse for not correcting his mount soon after the start, causing interference. It was a unanimous decision he receive the following penalty.

Jockey **SALOMON SALGUERO**, who rode **STOLEN GROOM** in the third race at Golden Gate Fields on Wednesday, November 21, 2007, is suspended three (3) racing days (November 29, 30, and December 1, 2007) for failure to make a proper effort to maintain a straight course leaving the starting gate and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules - careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

11-23-07³ **INQUIRY - NO CHANGE - First Race (Turf)**

Following the running of the first race the stewards lit the inquiry sign to review a possible infraction near the 5/8 marker. After conversation with the riders involved and the patrol judge, it was a unanimous decision to let the original order of finish to stand.

The film showed #3 ANOTHER EVENT (5th, Mario Gutierrez) did shift out, bumping #6 FLASHY HELMSMAN (7th, Alfredo Miranda) causing that one to slightly brush #9 REAL CHILL (9th, Luis Contreras), none of which effected the outcome of the race.

11-23-07⁴ **INQUIRY - ACCIDENT - NO CHANGE - Ninth Race (All Weather)**

Upon the finish of the ninth race the inquiry sign was posted to review a spill, which occurred at the wire. The #5 SHATTERED DANCER (11th, Kyle Kaenel) went wrong, falling and unseating the jockey. After a review of the film, the stewards were in agreement there were no other horses involved and made the race official. Accident report attached.

Trainer **WILLIAM E. MOREY** met with the stewards for a formal hearing to adjudicate case number 07BM135 which alleged violation of California Horse Racing Board rules #1844 (a)(b)(c)(1) (Authorized Medication) and #1866 (Veterinarian's List).

In attendance were the Board of Stewards, Senior Investigator Anne Glasscock, Special Investigator Gabriel Palomar, track veterinarian Dr. Heather Kerr and court reporter Janine Gamble. The record was opened and after the swearing in of witnesses and the examination of testimony from both sides, the hearing was closed. The decision will follow.

11-24-07³**RULING NO. 12 - GAINES**

Trainer **CARLA A. GAINES** is fined the sum of three hundred dollars (\$300.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to ship the horse MRS. ROCHA, necessitating a late declaration from the seventh race on Friday, November 23, 2007; a violation of California Horse Racing Board rule #1698 (Failure to Start and Run).

The above ruling was issued after a telephone hearing with Ms. Gaines wherein she accepted full responsibility for her trainee not being available to race.

11-24-07⁴**RULING NO. 13 - PEREZ**

Trainer **MAG PEREZ** is fined the sum of three hundred dollars (\$300.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to ship the horse QUI'S DETERMINED, necessitating a late declaration from the ninth race on Friday,

November 23, 2007; a violation of California Horse Racing Board rule #1698 (Failure to Start and Run).

The above ruling was issued after Mr. Perez was informed by telephone of his penalty. He stated his shipping arrangements fell through after the publication of the overnight. Mr. Perez was disgruntled when told once he entered, he was obligated to run.

11-24-07⁵ **FILM REVIEW**

Jockey **Mario Gutierrez** came before the board to review the first race on November 23, 2007. Mr. Gutierrez was warned that in the future when his horse shifts positions in a race it is necessary to see a visible reaction from him to disallow responsibility.

11-24-07⁶ **INQUIRY / ACCIDENT - BREAKDOWN - Fifth Race (Turf Course)**

After the running of the fifth race the inquiry sign was posted to review the incident in which #1 HONOR SPIRIT (A. Sanguinetti) who went wrong, unseating the jockey. Upon the findings that there were no other horses involved, the race was made official. Accident report attached.

11-24-07⁷ **BRIEF ERROR - Sixth Race**

After the finish of the sixth race the numbers were posted by the placing judges, the top two finishers were posted along with the photo. The place position on the board flashed the wrong number for a brief moment. Upon being corrected, the proper numbers were broadcasted by the track announcer.

The issue was discussed after the race in the stewards' stand with both placing judges as to what occurred and how to prevent it in the future.

11-24-07⁸ **INQUIRY - NO CHANGE - Ninth Race (All Weather)**

Following the finish of the ninth race the stewards posted the inquiry sign to review a possible infraction, which occurred late in the stretch. After the viewing of the film, talking to all jockeys involved and the patrol judge, it was a collective decision to let the original order of finish stand.

The tapes show #1 SWEET ON CASH (1st, L. Contreras) made a slight step in and #6 SHANES TANK (6th, F. Alvarado) made a slight step out, thus causing #4 MO MONEY HONEY (3rd, C. Silva) to shift. In the stewards' opinion this movement did not cost #4 MO MONEY HONEY the opportunity of a better placing.

11-25-07³**MOREY DECISION** (Refer: 11-24-07²)

After careful consideration the stewards collectively decided to dismiss case #07BM135, involving **William E. Morey's** alleged California Horse Racing Board rule violations.

Mr. Morey testified he felt he had performed the proper procedures to remove his horse from the Vet's List before the entry was submitted. Upon acceptance of the entry from the racing office, Mr. Morey stated he had no reason to believe the horse was still on the list.

In the stewards' opinion, the blame for the breakdown in the policies and procedures of removing horses from lists could not be placed on any one individual or department.

11-25-07⁴**INQUIRY - ACCIDENT - NO CHANGE - Fourth Race (All Weather)**

Following the running of the fourth race the inquiry sign was posted to review an accident which occurred leaving the $\frac{3}{4}$ chute, crossing onto the main track, wherein #1 RHYTHM QUEST (Jockey A. Rojas) ducked in, dislodging the jockey at the end of the chute. Upon review of the film and conversation with the patrol judge, it was confirmed there were no other horses involved and the race was made official. Accident report attached.

11-25-07⁵**INQUIRY / JOCKEY OBJECTION - ACCIDENT - NO CHANGE - Eighth Race (Turf Course)**

As the eighth race crossed the finish line the stewards marked the tote board with the inquiry sign to review an accident, which occurred near the 1/8th pole where #2 RILEYS RAINBOW (Jockey J. Martinez-Campos) bolted to the outside fence and unseated the jockey. This incident did not involve any of the other horses in the race. The second half of the inquiry joined by a rider's objection for a possible infraction near the sixteenth marker; involved #3 MANNINGTOHARRISON (2nd, C. Gonzalez) who claimed foul against #5 SASSOU (1st, G. Almeida).

After a review of the film and taking into account the reports from both riders involved and the patrol judge, on a majority vote (Steward Nevin dissenting) the stewards let the original order of finish stand. It was the majority opinion that even though #3 was brushed and pushed out down the lane by #5, he was not cost the opportunity at a better placing.
