Outrider **NANCY BARNEY** appeared to address the issue of an expired California Horse Racing Board license. Ms. Barney declared she did not intentionally avoid renewing her license and promptly did so when she was made aware that hers had expired. Ms. Barney was dismissed with a stern warning and a promise from her that it would not happen again.

12-13-07³ **RULING NO. 25 - PURSE REDISTRIBUTION - CASE #07BM111** (Refer 12-06-07)

Acting upon a report from the University of California, Davis Maddy Analytical Laboratory, the official laboratory for the California Horse Racing Board, that the urine sample, #BM02554, taken from the horse EL SIERRA TAHOE, first place finisher in the ninth race at Bay Meadows Race Course on September 1, 2007, showed the presence of 3 - Hydroxy Lidocaine, a metabolite of Lidocaine (Class II), it is hereby ordered that EL SIERRA TAHOE be disqualified from said race and unplaced. All monies earned (\$10,200.00) by owner Philip Lebherz and George Schmitt, trainer Jeff Bonde and jockey Roberto Gonzalez are ordered returned to the Paymaster of Purses for redistribution pursuant to California Horse Racing Board rule #1760 (Purse Award or Prize to be Withheld).

The foregoing ruling was issued upon the findings of a positive test result of the horse EL SIERRA TAHOE.

12-13-07⁴ **RULING NO. 26 – BONDE – CASE 07BM111** (Refer: 12-06-07³)

Trainer **JEFF BONDE** is fined the sum of one thousand dollars (\$1,000.00) for violation of California Horse Racing Board rule #1890 (Possession of Contraband) on September 19, 2007.

The above ruling was issued after the stewards agreed that the unused syringes found in Mr. Bonde's office/tack room at the Pleasanton Fairgrounds were more than likely distributed by the attending veterinarian, as testified at the formal hearing, for use as a dose syringe to administer the drug Regumate orally, without attaching a needle thereto.

Mr. Bonde is now aware it is his responsibility, when such instruments are left in his care, to make sure the tips are adjusted making them legal to be in his possession and rendering them inoperable.

12-13-07⁵ **RULING NO. 27 – KUHLMANN – CASE #07BM125** (Refer: 12-06-07³)

Owner/Veterinarian **KIM KUHLMANN, D.V.M.**, who treated the horse EL SIERRA TAHOE, the winner in the ninth race at Bay Meadows Race Course on September 1, 2007, is suspended thirty (30) days, (December 20, 2007 through January 18, 2008) pursuant to California Horse Racing Board rule #1887 (a) (Trainer to Insure Condition of Horse) for the negligent administration of the Class II prohibited substance, 3-Hydroxy Lidocaine, a metabolite of Lidocaine, which was present in a post race urine sample; a violation of California Horse Racing Board rules 1845(e) (Authorized Bleeder Medication), 1843.5 (c) (Medication, Drugs and Other Substances Permitted after Entry in a Race) and 1843.5 (a) (b) (d) (Medication, Drugs and Other Substances).

During the term of suspension, all licenses and license privileges of KIM KUHLMANN are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) he is denied access to all premises in this jurisdiction.

The above ruling was issued after Dr. Kim Kuhlmann took full responsibility for the positive test finding on the horse EL SIERRA TAHOE (trainer Jeff Bonde). Dr. Kuhlmann stated the horse was mistakenly given the drug Lidocaine (Class II) instead of the lasix treatment four hours prior to post time on race day. Although this appears to be an honest mistake, it was the Board's feeling that it is an extremely important responsibility of the practicing veterinarian to ensure the proper drug is administered and being accountable for closely monitoring the administration of Class I, II and III drugs. Dr. Kuhlmann's clean record and above-board honesty were taken into consideration as mitigating circumstances when making this decision.

12-13-07⁶ **RULING NO. 28 – REDISTRIBUTION (Case #07BM128)** (Refer 12-07-07⁴)

Acting upon a report from the University of California, Davis Maddy Analytical Laboratory, the official laboratory for the California Horse Racing Board, that the urine sample, #BM02806, taken from the horse YODELAY YOU'RE WHO, first place finisher in the second race at Bay Meadows Race

Course on September 26, 2007, showed the presence of Procaine (Class III) in excess of the specified level, it is hereby ordered that YODELAY YOU'RE WHO be disqualified from said race and unplaced. All monies earned (\$7,200.00)

by owner Scott D. Sherwood, d.b.a. Blinkers on Racing Stable, trainer Greg Gilchrist and jockey Russell Baze are ordered returned to the Paymaster of

Purses for redistribution pursuant to California Horse Racing Board rule #1760 (Purse Award or Prize to be Withheld).

The above ruling was issued upon the findings of a positive test of the horse YODELAY YOU'RE WHO.

12-13-07⁷ **RULING NO. 29 - GILCHRIST**

Trainer **GREG GILCHRIST**, who started the horse YODELAY YOU'RE WHO, winner of the second race at Bay Meadows on September 26, 2007, is fined the sum of fifteen hundred dollars (\$1,500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1844(e) (7) (Authorized Medication) and #1843(a) & (d) (Medication, Drugs and Other Substances: Procaine [Class III] in excess of the specified level).

The above ruling was issued after deliberating Mr. Gilchrist's responsibility in the positive test result of the horse YODELAY YOU'RE WHO. In the opinion of the stewards the practicing veterinarian most likely gave the injection of procaine penicillin to the wrong horse, one of two geldings recently castrated and stabled in Mr. Gilchrist's barn. Trainer Gilchrist's exemplary record and forthright testimony were taken into consideration but he is still culpable for having the wrong horse available for the injection given.

12-13-07⁸ **RULING NO. 30 - SILVA**

Jockey **CARLOS SILVA**, who rode **ACQUIRE THE FIRE** in the seventh race at Golden Gate Fields on Wednesday, December 12, 2007, is suspended three (3) racing days (December 26, 28 and 29, 2007) for failure to make a proper effort to maintain a straight course leaving the starting gate and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules - careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The preceding ruling was issued after a film review with jockey Silva wherein the obvious was his lack of effort to control his horse out of the gate. Mr. Silva stated he will make a better effort in the future.

As the field crossed the finish line the inquiry sign was posted to review an incident wherein #1 SCALDING PASSION (Jockey J. Martinez-Campos) while on the lead, ducked in close to the 3/16th marker, jumping the fence and unseating jockey Martinez-Campos. The race was made official upon the collective decision the horse acted on his own accord and no other entrants were involved.

12-15-07⁵ **INQUIRY - DISQUALIFICATION - Fourth Race** (Six Furlongs - All Weather track)

Following the finish of the fourth race, the inquiry sign was lit to review a possible infraction past the 1/8th pole involving #2 THUNDERING JUSTICE (2nd, J. Martinez-Campos) and #8 SAIPAN (3rd, C. Schvaneveldt).

After a review of the films and conversation with the patrol judge it was a unanimous decision to disqualify #2 for drifting in taking the path of #8 and costing the latter an opportunity at a better placing.

12-16-07¹ **RULING NO. 31 - EDGERLY** (Case #07GG128 / Case #07GG144)

Trainer **KENNETH EDGERLY**, who started the horse **FAMA Y DINERO**, winner of the fifth race at Golden Gate Fields on November 17, 2007 and **SEPARATE INTEREST**, winner of the fourth race at Golden Gate Fields on November 29, 2007, is fined the sum of one thousand dollars (\$1,000.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone – in excess of permitted level – 6.87 mcg/ml and 5.82 mcg/ml).

The above ruling was issued after an informal hearing with Mr. Edgerly where the two cases were combined and the penalty awarded was deemed appropriate. Mr. Edgerly stated his medication has been examined and revised so this will not occur in the future.

12-16-07² **RULING NO. 32 - MARTINEZ-CAMPOS**

Apprentice Jockey **JOSE MARTINEZ-CAMPOS**, who rode **THUNDERING JUSTICE** in the fourth race at Golden Gate Fields on Saturday, December 15, 2007, is suspended five (5) racing days (December 26, 28, 29, 30 and 31, 2007) for failure to make the proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to third; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall prohibit participation in designated races in California.

The above ruling was issued after Mr. Martinez-Campos appeared to review his ride on

December 15, 2007. Mr. Martinez-Campos acknowledged his guilt in drifting when not in the clear. He was handed a five day penalty. Steward Nevin felt a seven (7) day suspension was appropriate. However, as this was Mr. Martinez-Campos' third riding violation of this meeting, permission to ride in designated races was not granted in compliance with California Horse Racing Board rule 1766 (b) (Designated Races).
