Thursday01-03-08¹**CAL-BRED REPORT**

Purse \$16,000. For Cal-Bred fillies, three years old, claiming price \$12,500 at six furlongs. The race failed to fill and was called off.

01-03-08²**CALVARIO HEARING**

A transcribed hearing was held today to address California Horse Racing Board complaint 07GG152 filed against trainer **Manuel Calvario** by **Blazing Feed** for alleged violation of CHRB rules #1876 (Financial Responsibility) and #1877 (Checks).

Present were stewards John Herbuveaux, Dennis Nevin and Darrel McHargue, Mr. Calvario, David Blazing and senior investigator Charles Smith. Christine Niccoli recorded the hearing.

The complaint alleged Mr. Calvario issued a check for \$10,000 to Blazing Feed that was returned for non-sufficient funds. Mr. Calvario did not dispute the allegation however, he requested additional time to make the check good in spite of the fact the check was returned on July 3, 2007 and to date has not made any attempts to repay the monies.

After due deliberation this Board made the decision the monies were to be paid in full by January 7, 2008 or Mr. Calvario's license will be suspended. More to come.

01-04-08⁴ **JOCKEY'S SAFETY CONCERNS - First Race Delay**

As the horses arrived in the paddock for the first race, the jockeys called the stewards and voiced their concerns for safety due to the high winds. It was widely reported by the news media that winds in the San Francisco area were clocked in excess of seventy miles an hour. After a brief meeting between the riders, management and the stewards, it was agreed by all parties to wait an additional thirty minutes, check the weather and make the decision to race or to cancel racing. The winds died down during that time and the first race started after a thirty minute delay with the entire program progressing without incident.

01-06-08³ **RULING NO. 46 - MASON**

Trainer **LLOYD MASON** is fined the sum of three hundred dollars (\$300.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for entering the wrong horse, necessitating a late declaration for MISS SOUGHT AFTER from the fifth race on Sunday, January 6, 2008; a violation of California Horse Racing Board #1894 (Duties of Trainer).

The ruling listed above was issued after Mr. Mason contacted the stewards and acknowledged he mistakenly entered the wrong horse.

01-06-08⁴ **INQUIRY - DISQUALIFICATION - First Race**

Following the running of the first race the inquiry sign was posted for a stewards' review of the stretch run involving #3 REAL SKY (2nd, Carlos Silva) and #4 SYLVIE (4th, Juan Ochoa).

After talking to the riders involved, reviewing the recorded views and looking at the photo finish for the show placings, #3 was disqualified from second to fourth.

The tapes show as #4 was moving into a clear opening and gaining on the leaders, #3 crosses over into the path of #4, taking that rivals path, forcing the rider of #4 to steady, lose momentum and a chance at a better placing. The show photo revealed #4 was only beaten a neck for that position.

01-06-08⁵ **ACCIDENT - INQUIRY - Fifth Race**

Following the running of the fifth race the inquiry sign was lit for a stewards' review of an accident near the 3/8 pole involving #8 TRUCKEE VICTORY (fell, Luis Contreras), #10 FREE TO KNIGHT

(fell, Leslie Mawing) and #5 BRAHMS BABE (6th, Roberto Gonzalez).

After reviewing the tapes of the race the order of finish as posted was declared official. The tapes show #8 sustains a catastrophic injury to its left foreleg and falls which caused #10 to fall after tripping over the fallen horse. #5 also stumbled badly after tripping over the fallen horse which caused its rider to lose his irons and almost fall off.

The injuries sustained by both horses, #8 and #10, were severe and to such a degree that euthanasia was administered. #8 was euthanized on the track and #10 was transported back to its stall and was euthanized after further examination.

Jockeys Gonzalez and Mawing were uninjured. Jockey Luis Contreras was transported to Highland Hospital for further examination. It was later reported he had a mild concussion and a shoulder injury.

01-06-08⁶ **ACCIDENT - INQUIRY - Seventh Race**

Following the running of the seventh race the inquiry sign was posted for a review of an accident where the six furlong chute joins the main track. The horse involved was #1 DESERT COWBOY, ridden by jockey Carlos Gonzalez.

After reviewing the recorded views the race was made official.

The tapes show #1 veers left as the horse left the chute and unseats jockey Gonzalez. Neither the jockey nor the horse sustained injury. The horse was caught by the outriders without further incident and Mr. Gonzalez fulfilled his riding engagements on the rest of the card.

01-07-08¹ **CAL-BRED REPORT**

Purse \$13,000. For Cal-Bred fillies three years old, claiming price \$10,000 at one mile. Only four horses entered the race and the race was called off.

01-07-08² **RULING NO. 47 - SILVA**

Jockey **CARLOS SILVA**, who rode REAL SKY in the first race at Golden Gate Fields on Sunday, January 6, 2008, is suspended five (5) racing days (January 14, 17, 18, 19 and 20, 2008) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fourth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules - careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The ruling listed above was issued after Mr. Silva reviewed the race with the stewards and candidly

acknowledged he made a mistake. He stated he knew his horse was drifting inward but he didn't know there was a horse coming through the opening on his inside and that the horse was on his heels. Five days were issued since this is Mr. Silva's second set of days since the 27th of December.

01-07-08³ **RULING NO. 48 - CALVARIO** (07GG152) (Refer: 01-03-08²)

Trainer **MANUEL R. CALVARIO** is hereby suspended pending redemption of a check to Blazing Feed in the amount of ten thousand dollars (\$10,000.00) which was returned for non-sufficient funds; a violation of California Horse Racing Board rule #1877 (Checks).

During the term of suspension, all licenses and license privileges of Manuel R. Calvario are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The preceding ruling was issued after Mr. Blazing, representing Blazing Feed, appeared before the stewards and reported Mr. Calvario failed to make restitution for the N.S.F. check.

01-07-08⁵ **DISPUTED HORSE PURCHASE**

Trainers Louis San Juan and Ken Edgerly were invited in to see if the disputed purchase of the horse DANCE MOMA could be resolved. This matter was brought before the stewards by Mr. San Juan who alleged he was still owed monies for the purchase of the horse. Mr. Edgerly held the position the monies were paid in full as stated in the bill of sale.

It was apparent during the discussion that Mr. San Juan and Mr. Edgerly have lost the capacity to resolve this matter as their business relationship has become acrimonious. It was alleged that racial remarks and threats were exchanged prior to this meeting which most likely added to the hostilities between the two.

After hearing both sides of the argument the stewards were of the opinion the purchase of the horse was complete and in compliance with the bill of sale.

01-07-08⁶ **ACCIDENT - INQUIRY - Seventh**

Following the running of the seventh race the inquiry sign was posted for a review of an accident near the quarter pole involving #6 CLASSY JO (5th, Roberto Gonzalez), #7 GAYLE'S GALA (fell, Mario Gutierrez) and #5 JANJEN (lost rider, Leslie Mawing).

After reviewing the recorded views of the race the order of finish, as posted, was declared official.

The tape shows #7 catch the heels of #6 and fall, with #5 tripping over the fallen horse and unseating its rider. The recorded views were inconclusive as to which horse was at fault therefore no change was made to the order of finish.
