10-04-08³ **JOCKEY DAVID LOPEZ WARNED**

A warning regarding maintaining a straight course was issued to jockey David Lopez after he reviewed the sixth race ran on October 3, 2008 with the stewards. The tapes show Mr. Lopez allowed his mount to crowd a horse on his inside and place that rival in tight quarters. Mr. Lopez was informed his actions bordered on carelessness and any future incidents of this nature would result in days.

10-04-08⁴ **DAB OF LIGHTNING – DISQUALIFICATION HEARING**

A disqualification hearing was scheduled to address California Horse Racing Board complaint 08GG119 filed by the Board after the horse DAB OF LIGHTNING tested positive for the Class II prohibited drug 3-hydroxylicocaine after racing in the ninth race at the Solano County Fair (Vallejo) on July 20, 2008.

Present for the hearing were stewards Dennis Nevin, Darrel McHargue and William Meyers, trainer Sean McLaughlin and Supervising Investigator Anne Glasscock. Certified Court Reporter Christine Niccoli recorded the proceeding.

Prior to opening the record a discussion was held regarding the procedural process of disqualifying a horse prior to having a hearing for the trainer.

After opening the record the question arose as to whether the owners of the horse were duly noticed for the hearing and a continuance was issued with instructions to send notices to all the owners.

10-05-08³ **RULING NO. 8 – NORTH**

Jockey Agent **MARK NORTH** is fined the sum of one hundred dollars (\$100.00) pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations) for failure to conduct his business in a proper manner on Saturday, October 4, 2008.

The preceding ruling was issued after Mr. North phoned the stewards and accepted full responsibility for failing to remove his rider from his mounts prior to scratch time.
