04-22-09¹ **EARLY DECLARATION – REFUND**

5th race: #5 LITTLE AVA (Tr. A. L. Diaz) injured a.m.
 Examining Veterinarian Diane Isbell REFUND: \$ 263.80

04-22-09² **STEWARDS' INQUIRY – NO CHANGE – Fifth Race**

The stewards posted the inquiry sign to review the start when #1 VIVA LA BEAU, trained by Gil Matos with Juan Ochoa in the irons, failed to leave the starting gate. Tapes of the race showed that the stall doors opened properly and VIVA LA BEAU refused to depart. This is the second refusal for the Matos trained filly who will now be placed on the barred list.

Matos contacted the stewards after the race and apologized for his charge's behavior. Weeks of schooling went for naught and he realized her racing future was in serious peril.

Owner **JAMES YEH**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before Wednesday, April 22, 2009, to answer charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility), is hereby suspended pending appearance before the Board of Stewards for violation of CHRB rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of JAMES YEH are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued after Mr. Yeh failed to respond to notice regarding a complaint filed by trainer **Steve Miyadi** who alleges \$5,673.00 due for a training bill.

04-23-09² **RULING NO. 75 – DELIMA** (Case No. 09GG111)

Trainer **CLIFF DELIMA**, who started the horse **LEI OF GOLD**, winner of the third race at Golden Gate Fields on March 19, 2009, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Prohibited Drug Substance; Trichlormethiazide – Class 4).

The above ruling was issued after Delima contacted the stewards by phone and pled guilty. Cliff explained he gave instructions to his groom to give Naquasone to the horse but the groom misunderstood and administered two packages over two days rather than two packages all at once.

During the term of suspension, all licenses and license privileges of KIM I. EISLER are suspended and pursuant to California Horse Racing

Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued after Eisler failed to appear to address a complaint filed by trainer Jerry Hollendorfer alleging \$175.00 due for a training bill.

A request for a continuance was sent to the Board office in Sacramento on April 21 but by majority vote, with steward Nevin dissenting, the request was deemed untimely and the suspension order issued.

04-24-09¹ **RULING NO. 77 – PAPAPRODROMOU** (Case No. 09GG133)

Trainer **GEORGE PAPAPRODROMOU**, having failed to respond to written notice to appear before the Board of Stewards on or before Thursday, April 23, 2009, to answer charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility), is hereby suspended pending appearance before the Board of Stewards for violation of CHRB rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of GEORGE PAPAPRODROMOU are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued after Papaprodromou failed to respond to written notice to appear to address a complaint filed by trainer **Monty Meier** alleging \$285.00 owed on a past due training bill.

04-24-09³ **SANCHEZ HEARING** (Case No. 09GG097)

A hearing was convened to address a complaint filed against jockey **ANGEL SANCHEZ** who was alleged to have violated California Horse Racing Board rules #1485 (License Subject to Conditions and Agreements) and #1874 (Disorderly Conduct). At a pre-hearing conference Sanchez and his attorney, Lorrie Anthony, reached a negotiated settlement with Anne Glasscock and Gabriel Palomar of the CHRB investigative staff, which calls for a thirty day postponement of the hearing. In the interim Sanchez will undergo an evaluation by a certified substance abuse counselor to determine if Sanchez does in fact need counseling. To be continued.

Initial perusal of the supporting documents revealed that only \$553.00 of the total sought by Smith was for services performed in a race related capacity. After hearing testimony from both parties and reviewing the evidence presented the stewards determined McAllister owed Smith \$500.00.
