In accordance with a stipulated settlement agreement with the California Horse Racing Board:

Trainer **JEFF BONDE**, who started the horse **HALO’S ANGEL**, second place finisher in the sixth race at the San Mateo County Fair at Bay Meadows on August 13, 2008, is hereby suspended thirty (30) days, fined the sum of three thousand dollars (\$3,000.00) and placed on probation for one year thru April 1, 2010 pursuant to California Horse Racing Board rule 1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule 1843(a) & (d) (Medications, Drugs and Other Substances – Trenbolone, Class 3).

As stated in the settlement agreement, twenty-five (25) days of the thirty (30) day suspension will be stayed with the condition that Mr. Bonde does not violate CHRB rules 1843, 1843.6 and 1887 regarding Class 1, Class 2, or Class 3 drug substances during the term of probation. The suspension days shall be May 11 through May 15, 2009.

During the term of suspension, all licenses and license privileges of JEFF BONDE are suspended and pursuant to California Horse Racing Board Rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The foregoing ruling was issued following the Board of Stewards’ approval of the stipulated settlement agreement.
