Jockey **SAUL ARIAS**, who rode **BETTERWINSOME** in the fourth race at the California State Fair (Sacramento) on Monday, September 7, 2009, is suspended three (3) racing days (September 17, 18 and 19, 2009) for failure to make the proper effort to maintain a straight course in the stretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above was issued after Mr. Arias and the stewards reviewed the tapes of the fourth race on September 7<sup>th</sup> from the California State Fair. Mr. Arias acknowledged his error and accepted the penalty.

09-12-09<sup>4</sup> **RULING NO. 2 – MIYADI** (09GG284)

Trainer **STEVE MIYADI**, who started the horse **SOVEREIGN RULER**, first place finisher in the eighth race at the Sonoma County Fair (Santa Rosa) on August 1, 2009, is fined the sum of one thousand dollars (\$1,000.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843(a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone – in excess of the permitted level – 5.75 ug/ml).

The foregoing ruling was issued after Mr. Miyadi waived his right to a hearing and accepted the penalty imposed for this offense, his second in a twelve month period.
