04-03-111 CAL-BRED REPORT

Purse \$8,200. For California bred or California sired maidens, three years old, claiming price \$8,000 at one mile. The race was called off with two entries.

After discussing the medication procedures followed at his barn, a warning was issued which is in compliance with California Horse Racing Board rule 1844 (c) (Authorized Medication) with regards to a trainer who has not had a 1844(c) violation within the previous three years.

**04-07-111 CAL-BRED REPORT**

Purse \$9,500. For California bred or California sired four year olds and upward, claiming price \$5,000 at five and one half furlongs. After receiving only one entry the race was called off.

**04-07-112 DECLARATION – REFUND**

1st race: #4 UPSTAIRS MAID (Tr. Bud Klokstad) Refused in post parade  
Stewards REFUND: \$10,884.30

The above scratch reduced the field to four wagering interests and in compliance with CHRB rule 1954 (Pari-mutuel Pools) show wagering was cancelled and the additional refund totaled \$743.21.

6th race: #6 MORAL DILEMMA (Tr. Art Riesgo) sick

**04-07-113 RULING NO. 53 – WRIGHT**

Owner WILLIAM S. WRIGHT is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for violation of California Horse Racing Board rule #1698 (Failure to Start and Run) necessitating a late declaration from the first race on Thursday, March 31, 2011.

The ruling listed above was issued after Mr. Wright contacted the stewards, acknowledged guilt, and waived his rights to a hearing. This was a case where the owner objected to his horse running in a race after the horse was already drawn into the race. The owner then removed the horse from the trainer's care and placed it in another trainer's barn.

**04-07-114 RULING NO. 54 – KUHLMANN**

Veterinarian KIM KUHLMANN, who treated the horse BIG SON OF A GUN, first place finisher in the fourth race at Golden Gate Fields on January 22, 2011, is fined the sum of one thousand dollars (\$1,000.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1843.5 (g) (1) (Medication, Drugs and Other Substances Permitted After Entry in a Race) and #1844 (c) (1) (Authorized Medication – Phenylbutazone – in excess of permitted level – 14.73 ug/ml [Class 4] ).

The preceding ruling was issued after the stewards reviewed the evidence and testimony presented at the formal hearing on April 2, 2011.

Dr. Kuhlmann accepted responsibility and acknowledged not being specific as to which horse he need for treatment on the day the horses were treated. He stated he works off the overnight and requested the horses by trainer and not by name which led to the same horse being treated twice with bute. Unfortunately for Dr. Kuhlmann the trainer, Vladimir Cerin, shipped two horses from southern California to trainer Armando Lage's barn that were in consecutive days and he (Dr. Kuhlmann) did not remember, or recognize, that the horse he was treating with lasix is the same horse he treated with bute an hour prior and twenty-four hours prior with bute.

The case against trainer Vladimir Cerin was dismissed by majority vote. Steward John Herbeveux was of the opinion trainer Cerin was trainer of record and should have been penalized.

**04-08-112 RULING NO. 55 – ROMERO**

Jockey HECTOR ROMERO, who rode LAMA CHANT in the second race on February 5, 2011, is fined the sum of three hundred dollars (\$300.00) for violation of California Horse Racing Board rule #1688 (b) (3) (Use of Whips – causing welts or breaks in the skin).

The foregoing ruling was issued after Mr. Romero, accompanied by Jockeys Guild representative Darrell Haire, met with this Board, reviewed the evidence and acknowledged guilt.
