- 11-03-11³ **FILM REVIEW**
 Jockey **Aaron Gryder** and the stewards reviewed the video of the fifth race from Sunday, October 30, 2011.
 Mr. Gryder was warned to be a bit more cautious about maintaining a straight course in the stretch.
- 11-03-11³ **RULING NO. 19 – DIAZ** (Refer: 11-02-11²)
 Trainer/Association Employee **MARY E. DIAZ**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before Wednesday, November 2, 2011, to answer charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility), is hereby suspended pending appearance before the Board of Stewards for violation of CHRB rule #1547 (Failure to Appear). During the term of suspension, all licenses and license privileges of MARY E. DIAZ are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.
- The foregoing ruling was issued as Ms. Diaz failed to appear for a scheduled hearing on November 2, 2011.
- 11-03-11⁴ **OWNER JAMES QUINN** (11SW0054)
 The stewards met with disgruntled partners **Pat Prendiville** and **James Quinn**, co-owners of one horse.
 Mr. Prendiville and Mr. Quinn both had counsel present and all agreed to proceed informally.
 At issue is Mr. Prendiville's complaint that Mr. Quinn is in arrears for training, boarding and veterinarian services totaling \$8,672.64. In addition, Mr. Quinn is holding the foal certificate of their horse PLAYABLE MISS, preventing it from racing.
- After a lengthy discussion, Mr. Prendiville offered to purchase Mr. Quinn's interest in their horse and withdraw his complaint. Mr. Quinn accepted the offer and the matter was resolved.
