The foregoing rulings were issued following a hearing held on September 9, 2012, to

address a Golden Gate Fields Security complaint alleging disorderly conduct (drinking and fighting).

Both individuals admitted their transgressions and accepted the penalties imposed.

09-14-12<sup>4</sup> **GREG KARKOR BARDAKJIAN (d.b.a. Janavar Thoroughbreds, LLC)** (12GG135)  
The Board of Stewards received notice from San Francisco Equine that owner **Greg Bardakjian** has satisfied his debt (\$773.75). Case dismissed.

09-14-12<sup>5</sup> **RICCI and LEESA THORESON (d.b.a RIVERVIEW FARMS)** (12GG104)  
**Ricci** and **Leesa Thoreson** have signed a payment agreement with San Francisco Equine to satisfy their overdue vet bill (\$13,346.54).

09-14-12<sup>6</sup> **LORENZO OCHOA – CLARE PEARS**  
Exercise riders **Lorenzo Ochoa** and **Clare Pears** met with the Board of Stewards to clear the air regarding two incidents on the track during morning workouts. Morning outriders Nancy Barney and Bob Anderson were also present, as was CHRB investigator Gabe Palomar.  
Ms. Pears took exception to Mr. Ochoa's horsemanship relating to the incidents. The outriders could not put the blame on Mr. Ochoa for either incident and have not seen any evidence of incompetence.  
No action taken.

09-14-12<sup>7</sup> **OBJECTION – Second Race – NO CHANGE**  
The stewards posted the objection sign following the second race at the request of jockey Jesus Velazquez (#5 SUMMER SUNTAN) third, who lodged a claim of foul against #2 TRUENO (Julien Couton), second, alleging interference in the stretch. After reviewing the video and interviewing the riders involved, the stewards dismissed the objection and made the original order of finish official.  
The video shows a slight shift outward by #2 TRUENO near the 1/8 pole, but the incident had no bearing on the outcome.

09-15-12<sup>3</sup> **RULING NO. 7 – JASMIN** (12GG137)  
Owner **ROBERT JASMIN**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before Friday, September 14, 2012, to answer charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility), is hereby suspended pending an appearance for a hearing before the Board of Stewards for violation of CHRB rule #1547

During the term of suspension, all licenses and license privileges of ROBERT JASMIN are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

Owner **Robert Jasmin** failed to appear regarding a financial complaint filed against him by San Francisco Equine for an overdue vet bill totaling \$612.00.

09-15-12<sup>4</sup> **DEAN GREENMAN** (12GG138)

Owner/Trainer **Dean Greenman** signed a payment agreement with trainer Dennis Patterson to satisfy a training debt (\$7,861.00).

09-15-12<sup>5</sup> **INQUIRY – NO CHANGE – First Race**

The stewards posted the inquiry sign following the first race for a review of an incident that took place soon after the start.

After considering the patrol judge's report, interviewing the riders involved and reviewing the video, the stewards made the original order of finish official. Unanimous decision.

The video shows #3 EGYPTIAN FEMME (Catalino Martinez), who finished first, drifts in slightly soon after the start causing #2 KAITLANS SONG (Russell Baze) sixth, and #1 HAZARDOUS (Irving Orozco) fourth, to steady briefly. The incident had no bearing on the outcome.

09-15-12<sup>6</sup> **ACCIDENT – INQUIRY –DISQUALIFICATION – Sixth Race**

The stewards put up the inquiry sign following the sixth race for a review of an accident in the stretch.

The video shows #6 DIAMOND GEEZAH (Frank Alvarado) second, drifts in near the 1/16 pole into the path of #5 BYE BYE SEE YA (Pablo Flores) causing the latter to clip heels and fall. #11 METTLER STATION (Irving Orozco) then stumbled and fell over #5 BYE BYE SEE YA.

After a thorough review the Board of Stewards decided unanimously to disqualify #6 DIAMOND GEEZAH from second to unplaced.

Initial report on the riders was a severe concussion for Mr. Flores and possible broken wrist for Mr. Orozco.

Both horses that fell escaped serious injury. Accident reports attached.

Original order of finish: 4 – **(6)** – 8 – 9 – 2 – 3 – 1 – 7 – 10

Official order of finish: 4 – 8 – 9 – 2 – 3 – 1 – 7 – 10

09-15-12<sup>7</sup> **INQUIRY – NO CHANGE – Ninth Race**

The stewards posted the inquiry sign following the ninth race to review an incident in the stretch involving #9 ONE LUCKY GUY (Pedro Terrero) second and #2 PELITO (Julian Couton) third.

After considering the patrol judge's report, interviewing the riders involved and reviewing the video, the stewards decided unanimously to make the original order of finish official.

The video shows #9 ONE LUCKY GUY drifts in slightly near the 1/16 pole and #2 PELITO steadies briefly. The incident did not affect the outcome.

09-16-12<sup>3</sup> **RULING NO. 8 – ALVARADO** (Refer 09-15-12<sup>6</sup>)

Jockey **FRANK ALVARADO**, who rode **DIAMOND GEEZAH (IRE)** in the sixth race at Golden Gate Fields on Saturday, September 15, 2012, is suspended ten (10) racing days (September 23, 27, 28, 29, 30, October 4, 5, 6, 7 and 8, 2012) for failure to make the proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to unplaced; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after the Board of Stewards met with jockey Frank Alvarado for a review of the sixth race from September 15, 2012. Mr. Alvarado was contrite and acknowledged he erred in allowing his mount to drift off course and impede a rival, resulting in a two horse spill.

09-16-12<sup>4</sup> **FILM REVIEW**

Jockey **Pedro Terrero** and the stewards reviewed the video of the ninth race from September 15, 2012. Mr. Terrero was cautioned about allowing his mount to drift when in close quarters.

The Board of Stewards also met with jockey **Pablo Fernandez** and warned him about using his whip on tiring horses. Steward Nevin dissented feeling a penalty was warranted.

09-16-12<sup>5</sup> **RIDER EXCUSED**

Apprentice jockey Irving Orozco, who was involved in a spill yesterday, was excused from his mounts today after track physician David Seftel, M.D., reported he suffered an undisplaced fractured scaphoid in his right wrist.

09-16-12<sup>6</sup> **OBJECTION – Sixth Race – NO CHANGE**

The Board of Stewards posted the objection sign at the request of jockey Francisco Duran (#7 SKATTLE SEATTLE, 2<sup>nd</sup>) who lodged a claim of foul against #3 DIXICO (Kerwin John), the winner, alleging interference in the stretch. After considering the patrol judge’s report, interviewing the riders involved and reviewing the video of the race, the stewards decided unanimously to disallow the claim of foul. The video shows nothing to warrant a disqualification.

09-16-12<sup>7</sup> **ACCIDENT – INQUIRY – Seventh Race**

The Board of Stewards posted the inquiry sign for a review of the start. The video shows #5 TIZ FITTING (David Lopez) stumbled and unseated his rider. No other horses involved.
