**RULINGS #73 & #74 – VETERINARIANS STEVE BOYER (13GG040) AND STEVE MATUSZAK (13GG041)**

Veterinarian **STEVE BOYER** is fined the sum of three hundred dollars (\$300.00)\* for failure to properly fill out a confidential report on February 23, 2013; a violation of California Horse Racing Board rule #1842 (Veterinarian Report).

Veterinarian **STEVE MATUSZAK** is fined the sum of three hundred dollars (\$300.00)\* for failure to properly fill out a confidential report on March 3, 2013; a violation of California Horse Racing Board rule #1842 (Veterinarian Report).

The foregoing rulings were issued as both veterinarians appeared before the Stewards on May 19, 2013 and acknowledged failing to list Carbazochrome (Class 4) on their confidential vet reports for horses they treated.

**RULING NO. 75 – JOCKEY CHRISTIAN SANTIAGO REYES**

Jockey **CHRISTIAN SANTIAGO REYES** who rode THIS ONE'S FOR MEL in the eighth race at Golden Gate Fields on Sunday May 19, 2013 is suspended five (5) racing days (May 31, June 1,

2, 6 and 7, 2013) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fifth. A violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The above ruling was issued after Mr. Reyes' agent, Fernando Navarro, represented the absent rider before the Board of Stewards. Mr. Navarro relayed Mr. Reyes' thoughts regarding the eighth race from Sunday May 19, 2013. According to Mr. Navarro, his rider acknowledged his error, with the only explanation being that he was trying too hard to win the race.
