The video shows #4 ARGYLE CAT attempting to move inside #1 UPTOWN BIG BROWN along the rail and initiating contact with the latter. The incident had no bearing on the outcome.

9-14-13³ **RULING NO.11 – GROOM ELIFONSO F. RIVERA (13GG0100)**

RULING NO.11

Groom **ELIFONSO F. RIVERA** is fined the sum of one hundred dollars (\$100.00)* for failure to obey an order issued by a California Horse Racing Board Investigator on August 23, 2103; a violation of CHRB rule #1930 (Obedience to Security Officers and Public Safety Officers).

The foregoing ruling was issued after Mr. Rivera responded to the complaint filed against him by California Horse Racing Board Investigator Louis Quezada.

According to the complaint, and by Mr. Rivera's admission, the groom obstructed and delayed Investigator Quezada's investigation involving the discovery of a hypodermic needle/syringe that is the subject of pending complaints.

9-14-13⁴ **ACCIDENT – INQUIRY – 6th RACE – NO CHANGE**

The Stewards posted the inquiry sign immediately following the running of the sixth race to review an accident near the 5/16 pole.

The video shows that #9 CLOUD HOPPER (Jockey – Abel Cedillo) ran up behind #6 TRIPLE ACTION (Jockey – William Antongeorgi), clipped that horses heels and fell. #4 SPEED ROUSER (Jockey – Pedro Terrero) stumbled over the fallen horse (CLOUD HOPPER) and fell. Four other horses were eased around the accident.

Jockeys Cedillo and Terrero were transported to a local hospital. Accident reports are attached.

RULINGS 12 AND 13 – TRAINER GENARO VALLEJO

RULING NO.12

Acting on an order of remand dated September 4, 2013 and pursuant to the terms of a stipulated agreement with the California Horse Racing Board Owner/Trainer **GENARO O. VALLEJO**, who started the horse RED DWARF, winner of the seventh race at Golden Gate Fields on April 12, 2012 is suspended ninety (90) days, fined the sum of three thousand dollars (\$3,000.00)* and placed on probation for one year from the date of this ruling pursuant to CHRB rule #1887 (a) (Trainer to Insure Condition of Horse) for violation of CHRB rule #1843 (a) (b) & (d) (Medication, Drugs and Other Substances – prohibited substance – Zilpaterol [Class 1]).

For cause, sixty days of the ninety day suspension are stayed provided Mr. Vallejo is not in violation of CHRB Rules and Regulations #1843, 1843.6 and 1887 regarding Class 1, 2 or 3 drug substances during the term of probation. If Mr. Vallejo violates a condition of his probation the above referenced sixty (60) day stay of suspension shall be lifted and the remaining actual suspension shall be imposed after notice and hearing. The thirty (30) day suspension shall be served from October 17, 2013 through November 15, 2013 inclusive.

During the term of suspension all licenses and license privileges of Owner/Trainer GENARO O. VALLEJO are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

RULING NO.13

Acting on an order of remand and a report from University of California at Davis Maddy Laboratories, the official Laboratory for the California Horse Racing Board that the post race urine sample GG14131 taken from the horse RED DWARF, first place finisher in the seventh race at Golden Gate Fields on April 12, 2012 contained the prohibited substance Zilpaterol (Class 1), it is hereby ordered that RED DWARF be disqualified from all purse monies earned and deemed unplaced, in accordance with California Horse Racing Board rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that all purse monies (\$5,335.00) earned or awarded to owner Battle Born Racing Stable, trainer Genaro Vallejo

and jockey Aaron Gryder be returned to the Paymaster of Purses for redistribution pursuant to California Horse Racing Board rule #1760 (Purse Award or Prize to be Withheld).

The revised order of finish is as follows:

- 1st – STROLL FOR US
- 2nd – MOLTO
- 3rd – DOWN TOWN CLYDE
- 4th – CAPTAIN PEG LEG
- 5th – IDOITMYWAYBABY

All records are ordered changed to reflect this ruling. In accordance with California Horse Racing Board rule #1956 (Race Declared Official), this ruling shall not affect the pari-mutuel payoffs.

The foregoing rulings were issued following an order of remand from the California Horse Racing Board.

INQUIRY – 5TH RACE – NO CHANGE

The Stewards conducted an inquiry following the fifth race for a review of an incident in the stretch involving #2 ANGEL OF HARLAN (Jockey – Dennis Carr) sixth and #9 PIPEDREAMING (Jockey – Frank Alvarado) eleventh.

After interviewing the riders involved and reviewing the video, the Stewards decided unanimously to make no change in the original order of finish.

The video shows mutual contact between the two rivals near the 1/16 pole and the incident had no bearing on the outcome.

INQUIRY – OBJECTION – 7th RACE – NO CHANGE

The Stewards posted the inquiry sign following the seventh race for a review of an incident near the 1/16 pole involving #1 RED CRÈME (Jockey – William Antongeorgi III) fifth, #2 ADMINISTER (Jockey – Juan Hernandez) first, #5 KING KELLY (Jockey – Inoel Beato) third and #9 ZEHNER’S ZENNA (Jockey – Leslie Mawing) second.

Trainer Monty Meier (#5 KING KELLY) claimed foul regarding the incident.

After interviewing the riders and reviewing the video, the Stewards decided unanimously to make the original order of finish official.

The video shows a couple of different shifts in the stretch involving the horses noted, but none of which warranted a disqualification.
