**RULING NO.67 – JOCKEY AGENT RUSTY GREINER**

Jockey Agent **RUSTY GREINER**, is fined the sum of one hundred dollars (\$100.00)\* pursuant to California Horse Racing Board Rule #1530 (Cases Not Covered by Rules and Regulations) for failure to conduct his business in a proper manner on Saturday, May 3, 2014.

The foregoing ruling was issued after Mr. Greiner acknowledged he was guilty of giving out two first calls resulting in complaints from the trainers.

05-08-14<sup>4</sup> **CLAIM VOID – 3<sup>rd</sup> RACE**  
 The Board of Stewards voided the claim submitted by trainer Vod Farris for the mare LUCY WIGGLES, the winner of the third race, after State Veterinarian Forrest Franklin reported the mare was lame in the right foreleg. LUCY WIGGLES was returned to trainer William Nolan's barn.

 The Cal-bred race for three year olds, six years old, claiming \$18,000. - \$20,000., failed to fill.

 A formal hearing was held for jockey Kyle Frey, who has been charged with alleged violation of California Horse Racing Board rules #1874.4 (Disorderly Conduct), #1530(Cases Not Covered By Rules and Regulations) and #1489(h).

Present for the hearing, in addition to the Board of Stewards, were Mr. Frey, Track Physician David Seftel M.D., Winners Foundation representatives Nora Lee and Armando Calero. CHRB Investigator Louis Quezada presented the case for the CHRB and Certified Shorthand Reporter Christine Niccoli recorded the proceedings.

Mr. Frey is alleged to have been under the influence of a prohibited substance on April 5, 2014.

Following the submission of oral testimony and documentary evidence the hearing was adjourned for the day. The record is to remain open for admittance of a report by the Winners Foundation on the financial impact of a ninety day in-house rehabilitation program. Also, Dr. David Seftel will submit information regarding the extent of the testing program provided by Kaiser Permanente Rehabilitation program. To be continued.

 The claim submitted by trainer Gordon Wells was voided by the Board of Stewards following the declaration of #2 CAHILL CHROME, who was declared on the recommendation of Track Veterinarian Sara Sporer, who indicated the horse was unsound in the left foreleg.

05-10-14<sup>3</sup> **RULING #68 – JOCKEY DENNIS CARR**

Jockey **DENNIS CARR** who rode LETS TALK DIAMONDS in the fourth race at Golden Gate Fields on Saturday, May 10, 2014 is suspended three (3) racing days (May 18, 22 and 23, 2014) for failure to make a proper effort to maintain a straight course in the stretch and causing interference; a violation of California Horse Racing Board Rule #1699 (a) (d) & (f) (Riding Rules- Careless Riding).

The above ruling was issued after Mr. Carr and the Stewards reviewed the video of the fourth race from Saturday, May 10, 2014.

Mr. Carr felt there were contributing factors that caused him to allow his mount to drift in and cause another rider to check sharply off heels. The Stewards were not convinced and Mr. Carr accepted the penalty imposed.

05-10-14<sup>4</sup> **INQUIRY – DISQUALIFICATION – 4<sup>th</sup> RACE**

The Stewards posted the Inquiry sign following the fourth race to review an incident at the start involving #5 ITHOUGHTIPAIDYOU (Jockey- Pablo Flores), who finished fourth.

After considering the Patrol Judges report, interviewing the riders involved and reviewing the video, the Stewards decided unanimously to disqualify #5 ITHOUGHTIPAIDYOU from fourth to fifth for interference soon after the start.

The video shows the horse drifts in soon after the start and impedes #4 LEGENDINGTON (Jockey – Pedro Terrero) third and #3 BEERTALK (Jockey – Cristobal Herrera) fifth, preventing the latter the opportunity of a better placing.
