08-22-14<sup>2</sup>**LATE SCRATCH – FIRST RACE - REFUND**

#5 FAMOUS SCISSORS, trained by Cinda Mahorney, was scratched during the loading process on the recommendation of track veterinarian Sara Sporer, DVM after she reported the filly unseated jockey Steven Herrera, flipped and ran off up the ¾ chute. On Vet's List. The refund amounted to \$23,157.26.

08-22-14<sup>3</sup>**LATE SCRATCH – SIXTH RACE - REFUND**

#7 EXCESS CHARM, trained by Jerry Weaver, was scratched during the warm-up period on the recommendation of Dr. Sporer after she diagnosed the filly as Unsound on the left front. On Vet's List. The refund totaled \$4,124.13.

08-22-14<sup>4</sup>**OBJECTION – SEVENTH RACE NO CHANGE**

The Stewards posted the Objection sign at the behest of jockey Steven Herrera (6<sup>th</sup>, Expensive Jet) who lodged a claim of foul against the winner, #10 RENO ROCKET, ridden by Russell Baze. Herrera alleged interference at the top of the stretch. After a thorough review the Stewards dismissed the Objection. Tapes revealed that Herrera initiated contact with Baze's mount by swinging a little wide entering the stretch but the contact was minor.
