Wednesday11-26-14¹**ENTRIES AND DECLARATIONS DUTIES**

Steward Herbuveaux was in attendance today to oversee declarations for tomorrow and entries for Saturday. Mr. Herbuveaux will continue with those duties for the remainder of the week.

Thursday11-27-14¹**CAL- BRED REPORT**

Purse \$9,500. For California bred or California sired three year olds and upward, claiming \$5,000., at six furlongs. The race was drawn with six wagering interests.

11-27-14²**CATALINO MARTINEZ RULING #23**

Jockey **CATALINO MARTINEZ** who rode **MOOGIE WOOGIE** in the eighth race at Golden Gate Fields on Sunday, November 23, 2014 is suspended three (3) racing days (December 4, 5 and 6, 2014) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to sixth; a violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules - Careless Riding).

The preceding ruling was issued after Mr. Martinez met with the Stewards and failed to present a valid explanation for his failure to keep his mount on a straight course.

JOCKEY JUAN HERNANDEZ FILM REVIEW

Jockey Juan Hernandez was invited in to review Sunday's 9th race (11/23/14) in which he rode #1 AALSMEER to a second place finish.

After reviewing all the recorded views and listening to his analysis and explanation the matter was determined to be poor judgement along with pilot error.

The recordings show his mount hop at the start while breaking a stride slow with jockey Hernandez placing the horse under strong restraint for the first half mile before making a late run down the stretch.

TRAINER JAMEY THOMAS MEETS WITH THE STEWARDS

Trainer Jamey Thomas met with the Board, as instructed, to explain his failure to follow the instructions of the Racing Veterinarian following the running of Sunday's (11/23/14) 3rd race. Mr. Thomas disregarded the Veterinarian's instructions to place his horse in the horse ambulance following the running of the race and proceeded to walk the horse to the test barn. Thomas explained that in his opinion the horse was walking soundly and did not need the horse ambulance. Decision to follow.

After talking to the riders involved and reviewing the different recorded views no change was made to the placings.

The recordings show the rider of #2 check his mount after #5 shifted out for racing room and take the path of #2. #2 was dropping back at the time of the incident and finished where it was reasonably expected to finish therefore no change was made to the placings.

Jockey **RICARDO GONZALEZ** who rode **DUKE OF DOOM** in the third race at Golden Gate Fields on Thursday, November 27, 2014 is suspended three (3) racing days (December 5, 6 and 7, 2013) for altering course without sufficient clearance around the far turn and causing interference. A violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The foregoing ruling was issued after Mr. Gonzalez and his agent, Ron Freitas, reviewed the race with the Stewards and Mr. Gonzalez acknowledged making an error in judgment when he altered his course without clearance.

Trainer **JAMEY THOMAS** is fined the sum of two hundred dollars (\$200.00)* pursuant to CHRB rule #1549 (Recommendation of Discipline) for failure to follow the instructions of the Racing Veterinarian following the running of the third race on Sunday November 23, 2014.

The preceding ruling was issued after the matter was given due consideration.

11-29-14⁵ **6TH RACE STEWARDS REVIEW**

A Stewards review was done following the running of the 6th race for an incident near the 1/8 pole involving #1 CONSULARIA (5th place – jockey Carson Sullivan) and #2 THE WIGGIS (6th place – jockey Abel Cedillo).

After a full review the race was made official.

The recordings show the rider of #2, Abel Cedillo, check his mount off the heels of #1 after that rival shifted in and took his path.

The recordings clearly show that although #2 was fouled, its placing was not affected.
