**RULING#91**

Owner **JUAN H. MOYA** is hereby suspended One Year, June 15, 2015 through June 14, 2016 and fined the sum of Ten Thousand Dollars (\$10,000.00)\* pursuant to California Horse Racing Board rule #1900 (Grounds for Suspension or Revocation) for violation of California Horse Racing Board rules #1489 (g) & (j) (Grounds for Denial or Refusal of License), #1581 (Racing Secretary to Establish

Conditions), #1629 (Penalty for Late Declaration) and pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations) rule #1878 (Workouts) for improperly identifying a horse during a workout at the Alameda County Fairgrounds on August 3, 2014 necessitating a late declaration for the horse **HEAT SEEKING** from the second race at the Sonoma County Fair on August 6, 2014.

During the term of this suspension, all licenses and license privileges of **JUAN H. MOYA** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

RULING#92

Owner **RODRIGO J. MALDONADO** is hereby suspended One Hundred and Eighty days, June 15, 2015 through December 11, 2015 pursuant to California Horse Racing Board rule #1900 (Grounds for Suspension or Revocation) for violation of California Horse Racing Board rules #1489 (g) & (j) (Grounds for Denial or Refusal of License), #1581 (Racing Secretary to Establish Conditions), #1629 (Penalty for Late Declaration) and pursuant to California Horse Racing Board rule #1530 (Cases not Covered by Rules and Regulations) rule #1878 (Workouts) for improperly identifying a horse during a workout at the Alameda County Fairgrounds on August 3, 2014 necessitating a late declaration for the horse **HEAT SEEKING** from the second race at the Sonoma County Fair on August 6, 2014.

During the term of this suspension, all licenses and license privileges of **RODRIGO J. MALDONADO** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

MARTIN**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before June 11, 2015, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule #1874 (Disorderly Conduct).

During the term of this suspension, all licenses and license privileges of **LANCE R. MARTIN** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

06-12-15<sup>3</sup>**ABEL CEDILLO RULING 94****RULING#94**

Jockey **ABEL CEDILLO** who rode **STELLAR ACT** in the fifth race at Golden Gate Fields on Thursday, June 11, 2015 is hereby suspended five (5) racing days (June 19, 20, 21, 25 and 26, 2015) for altering course without sufficient clearance soon after the start and causing interference. A violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The term of this suspension shall not prohibit participation in designated races.

The ruling listed above was after Mr. Cedillo met with the Stewards reviewed the race and acknowledged being at fault in failing to straighten his mounts course. The recordings show Mr. Cedillo break from the outside, post #9, then angle in forcing #8 into the path of #6 which caused the rider of #6 to take evasive action to avoid heels.

06-12-15<sup>4</sup> **ANGEL AVILA BAUTISTA HEARING**

A hearing was held this morning to address California Horse Racing Board complaint 15GG0056 filed against owner/association employee Angel Bautista. Mr. Bautista was cited after being observed consuming alcohol and gambling prior to his work shift at Golden Gate Fields. He was subsequently tested and tested positive for recent alcohol consumption. Present in addition to this Board were Mr. Bautista, Attorney James Ghidella, Interpreter Kathy Marsili, Winners Foundation Representative Nora Lee, California Horse Racing Board Attorney Phil Laird, Union Representative Timothy Brown, and California Horse Racing Board Investigator Luis Quezada.

Due to time constraints the hearing could not be completed and was rescheduled for completion on June 14, 2015.

BAUTISTA**, who started the horse **MAYDAY MALONE**, second place finisher in the third race at Golden Gate Fields on May 2, 2015, is fined the sum of Five Hundred Dollars (\$500.00)\* pursuant to California Horse Racing Board rule #1877 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Methocarbamol – In excess of permitted level: 3.7 ng/ml [class 4]).

The preceding ruling was issued after Mr. Bautista pled guilty with an explanation of not allowing enough clearance time for the medication to clear the horse's system. He stated he would adjust the administration time from four days prior to the race to five days.

Jockey **KYLE FREY** who rode **BOLD DECISION** in the first race at Golden Gate Fields on Friday, June 12, 2015 is hereby suspended three (3) racing days (June 20, 21, and 25, 2015) for failure to make a proper effort to maintain a straight course in the stretch and causing interference. A violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The term of this suspension shall not prohibit participation in designated races.

The foregoing ruling was issued after Mr. Frey reviewed the race with the Stewards and acknowledged guilt.

ruling #93, dated June 12, 2015, suspending Mr. Martin for violation of California Horse Racing Board rule #1547 (Failure to Appear) is set aside.

Further, Mr. Martin is fined the sum of One Hundred Dollars (\$100.00)\* for creating a disturbance at the stable gate on April 30, 2015; a violation of California Horse Racing Board rule #1874 (Disorderly Conduct).

The ruling listed above was issued after Mr. Martin appeared along with Golden Gate Fields Security personnel, Ken O'Toole, and Pat Larkin to address the matter. Mr. Martin acknowledged getting angry and verbally abusive after being denied access to the barn area until he produced his license.

The first incident: The recordings show the rider of #3 MR RIVER OF DREAMS (8<sup>th</sup> place) Barrington Harvey check his mount on the 3/8 turn while racing inside #6 DUMA COUNCIL (2<sup>nd</sup> place – jockey Cristobal Herrera). The recordings show #6 step inward as #3 failed to make the turn and stepped outward. It was a majority decision. Steward John Herbuveaux was of the opinion #6 was solely responsible for the incident.

The second incident: The recordings show the rider of #1 DOC WEST (4<sup>TH</sup> place) CC Lopez check his mount along the rail near the 1/16 pole after the horse in front of him #5 NAE' OLE (3<sup>rd</sup> place – jockey Kyle Frey) began to tire and drop back. It was a unanimous opinion #1 caused its' own problems therefore no change in placings were made.
