12-26-2015³ **RULING #1-RUSSELL BAZE**

Jockey **Russell Baze** who rode Atta' Boy Woody in the ninth race at Golden Gate Fields on Sunday, December 13, 2015 is fined the sum of One Hundred Dollars (\$100.00)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

The above ruling was issued after Mr. Baze and the Stewards reviewed the video of the ninth race from December 13, 2015.

Mr. Baze acknowledged he struck his mount four times with the crop approaching the wire, as he was nosed out for the win.

12-26-2015⁴ **CLAIM VOIDED**

The Stewards voided a claim submitted by trainer Jed Josephson for an unknown horse in the eighth race. All was in order on the claim slip, with one exception, the name of a horse.

12-27-2015⁴ **ACCIDENT-INJURY-3RD RACE**

The Stewards posted the inquiry sign following the third race to review an accident near the ¼ pole. #1 On Time Cat fell while trailing the field.

Track veterinarian Sara Sporer DVM reported the three year old gelding broke his left foreleg and was euthanized on the track. Jockey Flores was transported to the hospital with possible neck and back injuries. Accident report attached.
