MIRANDA RULING (CASE # 16GG0030)

#81

Exercise rider **Enrique D. Miranda** having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before April 10, 2016, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule #1924 (Association to Prevent Unauthorized Access to Restricted Areas), #1902 (Conduct Detrimental to Horse Racing) and #1874 (Disorderly Conduct).

During the term of this suspension, all licenses and license privileges of **Enrique D. Miranda** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued after Mr. Miranda failed to put in an appearance at a hearing convened on his behalf.

04-14-2016³ **RICH RULING (CASE #16GG0029)**

Trainer **Eduardo Rich**, who started the horse **Silver Marquise**, third place finisher in the first race at Golden Gate Fields on February 21, 2016, is fined the sum of Five Hundred Dollars (\$500.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Flunixin in excess of permitted level- 61.4 ng/ml [Class 4]).

Trainer Eddie Rich appeared and waived his right to a formal hearing. Rich explained he administered a Banamine paste to Silver Marquise after his attending veterinarian was too busy to administer the substance via syringe the day before the race. Stewards explained the volatility of paste and Rich stated he would only use it for his training regime in the future.

Trainer **Tim McCanna** is hereby fined the sum of One Hundred Dollars (\$100.00)* for failure to follow proper procedures when declaring the horse **Tiki Torch** will race unshod in the Third race on Thursday, April 14, 2016; a violation of California Horse Racing Board rule #1853 (Examination Required).

The above ruling was issued after McCanna was contacted by phone and waived his right to a hearing. Tim acknowledged he misinterpreted the rule pertaining to horses running unshod but now knows he must report all changes on the entry blank.

04-15-2016³ **VOIDED CLAIM**

A claim deposited by Trainer John Brocklebank for the horse Princess Bertrando in today's third race was declared void by the Stewards after Official Veterinarian Forest Franklin determined the filly was unsound in the right front and placed her on the Vet's List. Princess Bertrando was returned to the barn of Jeff Bonde

04-17-2016² **ARIAS RULING****#85**

Jockey **Saul Arias** who rode **ET TOI** in the eighth race at Golden Gate Fields on Saturday, April 16, 2016 is suspended three (3) racing days (April 24, 29 and 30, 2016) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from seventh to tenth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after jockey Julien Couton represented Mr. Arias who returned home to Southern California following the race. Couton stated that Arias admitted his mount drifted in during the stretch run and the Stewards concurred. Had Arias corrected said drift the interference would have been avoided as well as the above penalty.

04-17-2016³ **CLAIM VOID**

A claim deposited by trainer Cliff DeLima for the horse Lucky Views in the ninth race was nullified after Dr. Franklin reported the horse was unsound in the hind-quarters and placed the horse on the Vet's List. Lucky Views was returned to the care and custody of trainer Any Mathis.
