In attendance besides the full Board of Stewards were California Horse Racing Board Investigator Louis Quezada, CSR Christine Niccoli, who transcribed the proceedings, Fernando Navarro, interpreter for Godoy, and Godoy. Due to uncertainties in regards to evidence presented a continuance was suggested and accepted by all parties.

08-26-2016<sup>2</sup> **BOBBIE BROWN HEARING**  
 A hearing was scheduled today in the case of suspended exercise rider Bobbie Jean Brown for violation of California Horse Racing Board rules #1485 (d), #1530, #1874 (2), #1900, #1902, #1930 & #1989 (a), (4) & (5).

This hearing was requested by Bobbie Brown with hopes of being reinstated. In attendance along with the Board of Stewards were California Horse Racing Board investigators Louis Quezada and Joe Mulligan, CSR Christine Niccoli and California Horse Racing Board counsel Phil Laird. Scheduled witnesses included two Golden Gate Fields Security Officers, Camillo Lopez and Major Bell, and Golden Gate Fields employee Julie Lagrave. Armando Calero representing the winners Foundation was observing.

The proceedings were scheduled for 11:00 am and after a 40 minute wait, with Bobbie Brown failing to make an appearance, it was determined that no action would be taken at this time and Bobbie Brown would remain suspended.

08-26-2016<sup>3</sup> **VIDEO REPLAY- 7<sup>th</sup> RACE**  
 During the review of films for the seventh race Jockey Alvarado appeared to violate the riding crop rule and was notified to meet with the Stewards to discuss this issue in the morning.

The previous six races were free of problems.

 Today's 6<sup>th</sup> race was listed in the program as a "main track" event when in reality it was scheduled for the Turf. Assistant Racing Secretary Linda Anderson was present to try and explain how the error may have occurred. Her 'proof' from entry day shows race carded as Turf. The only explanation is a possible glitch in the InCompass "RTO" program when final is sent between racing office and printer. Racing Office staff are talking with InCompass about this situation.

08-27-2016<sup>3</sup> **RULING #6-FRANK ALVARADO**

Jockey Alvarado was present to review video of the previous day's 7<sup>th</sup> race. He acknowledged that in the heat of action he was overzealous and may have struck his mount more than allowed.

Jockey **Frank Alvarado** who rode **Looktheotherway** in the seventh race at Golden Gate Fields on Friday, August 26, 2016 is hereby fined the sum of One Hundred Dollars (\$100.00)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

08-27-2016<sup>4</sup> **RULING #7-JEFF METZ**

After being reached by telephone by the Stewards to discuss the late scratch of the horse Stormin' Promise from previous day's race, the following ruling was issued:

**#7**

Trainer **Jeff Metz** is fined the sum of Three Hundred Dollars (\$300.00)\* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to deliver the horse **Stormin' Promise** to the Receiving Barn necessitating a late scratch in the seventh race on Friday, August 26, 2016; a violation of California Horse Racing Board rule #1852 (Reporting to Receiving Barn).

08-27-2016<sup>5</sup> **NO SHOW WAGERING**

Due to late morning scratch of #3 Gloria's Angelo the field was reduced to four betting interests resulting in a "No Show" wagering event.

08-27-2016<sup>6</sup> **INQUIRY/DISQUALIFICATION-RACE #1**

In deep stretch #1 "Atta' Boy Woody" drifted out under left handed whipping brushing slightly with runner-up #5 "Aperfectdaytofly". The runner-up was regaining on #1 at the wire being beaten in a photo. It was unanimous decision to disqualify "Atta' Boy Woody" and place him behind "Aperfectdaytofly".

08-27-2016<sup>7</sup> **LATE SCRATCHES- RACES THREE AND SIX**

Race 3-#3, Many Treats (Trainer: Ellen Jackson) unseated jockey William Antongeorgi in the Post Parade and ran off close to  $\frac{3}{4}$  of a mile. This action caused the Stewards to withdraw him from the race. Neither horse nor rider suffered any injuries.

Race 6-#5, Ichifoot, (Trainer: Aggie Ordonez), while approaching the Starting Gate, dropped rider William Antongeorgi and exited the turf course running into a retention pond, initializing him being withdrawn from the race by the Stewards. No injuries were sustained by equine nor human.

08-28-2016<sup>2</sup> **RULING #8-CATALINO MARTINEZ**

The following ruling was issued after Jockey Catalino Martinez accompanied by his agent, Fordel Fierce, reviewed video from Saturday's 1<sup>st</sup> race.

Jockey Martinez's mount Atta Boy Woody drifted out deep stretch slightly brushing and carrying the runner-up, Aperfectdaytofly, out. The bothered horse came on again at the wire to be beaten in a photo thus the disqualification. Mr. Martinez was deemed to be accountable for the incident.

**#8**

Jockey **Catalino Martinez**, who rode **Atta' Boy Woody** in the first race at Golden Gate Fields on Saturday, August 27, 2016 is hereby suspended three (3) racing days (September 4, 5, and 9, 2016) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to second; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

08-28-2016<sup>3</sup> **RULING #9-KYLE FREY****#9**

Jockey **Kyle Frey** who rode **Jen's Journey** in the third race on Saturday, August 27, 2016 at Golden Gate Fields is hereby fined the sum of One Hundred Dollars (\$100.00)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

The above ruling was issued after jockey Kyle Frey visited the Stewards to review footage of yesterday's 3<sup>rd</sup> race to discuss a possible violation of the Crop rule. Mr. Frey at first was questioning until he observed in the video that he had struck his mount four consecutive times, hind quarters and shoulder.

08-28-2016<sup>4</sup> **FILM REVIEW-JUAN HERNANDEZ**

Jockey Hernandez met and reviewed video from Saturday's 7<sup>th</sup> race. There was a question as to the possibility that the rider had hit his mount in the area of the head near the finish of the race. After review and talks with rider, who admitted to violation, a ruling will be issued based on further discussion among this panel of Stewards.

08-28-2016<sup>6</sup> **OPENING DAY MUTUEL ERROR (AUGUST 19, 2016)**

The mutual department provided this Board of Stewards letter of explanation concerning wrong takeout rate being used on Daily Doubles for the first day (see first week Minutes, Friday August 19, 2016).

Letter is attached to minutes. It should be noted that Golden Gate Fields is matching the amount of the error and donating it to the Winners Foundation.
