**MORNING DUTIES**

Steward John Herbuveaux was on hand to supervise entries and scratches. Nine races were drawn for Saturday.

**THURSDAY**11-17-2016<sup>1</sup>**MARTINEZ RULING****#14**

Jockey **Catalino Martinez** who rode **Highland Lad** in the third race at Golden Gate Fields on Sunday, November 13, 2016 is suspended three (3) racing days (November 24, 25 & 26, 2016) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fourth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Mr. Martinez appeared and viewed replays of Sunday's 3<sup>rd</sup> race. Martinez agreed that he straightened his mount only once when he should have straightened a second time to avoid interference.

11-17-2016<sup>2</sup>**MEDINA RULING****#15**

Owner/Exercise Rider **Gustavo G. Medina** is hereby fined the sum of One Thousand Dollars (\$1,000.00) for failure to procure the proper license while acting in the capacity of trainer; a violation of California Horse Racing Board rule #1481 (Occupational Licenses and Fees).

The above ruling was issued after Gustavo Medina admitted to this Board of Stewards that he was caring for the horse "Count On Me" for himself and his brother Luciano who are the owners. Holly Evans was the previous trainer listed and gave up that position over three weeks ago. After a lengthy discussion with Medina and trainer Sergio Perez it was agreed that Perez would now be the trainer of "Count On Me" and any change would be reported to the Board of Stewards.

### 11-18-2016<sup>1</sup> **CEDILLO RULING**

#### **#16**

Jockey **Abel Cedillo** who rode **Rhett's Image** in the fourth race at Golden Gate Fields on Thursday, November 17, 2016 is fined the sum of One Hundred Dollars (\$100.00)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

The above ruling was issued after Cedillo appeared and reviewed the stretch run of the 4<sup>th</sup> race. He realized that he used the crop four times without pausing and stated it was his fault for forgetting while vying for the lead.

11-18-2016<sup>2</sup> **2<sup>ND</sup> RACE POST PARADE DELAY**  
#1 Padawon trained by Andreas Psarras lost a shoe in the post parade. All horses were ordered back to the paddock and Horseshoe Inspector Augustine Rayas was summoned to re-attach the shoe. A four minute delay of the start resulted.

11-18-2016<sup>3</sup> **4<sup>TH</sup> RACE START DELAYED**  
#4 Gray Madam flipped in the gate unseating jockey Catalino Martinez and eventually running off in this mile turf race. #4 was scratched on the recommendation of Track Veterinarian Sara Sporer. There was a slight delay while the outriders rounded up the #4.

#### **#17**

Jockey **Pedro Terrero** who rode **Giant Mark** in the seventh race at Golden Gate Fields on Friday, November 18, 2016 is fined the sum of One Hundred Dollars (\$100.00)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

The above ruling was issued after Terrero viewed the video replays of yesterday's 7<sup>th</sup> race stretch drive with the Stewards. Mr. Terrero agreed he needs to take a longer pause when cropping.

### 11-19-2016<sup>2</sup> **OFF THE TURF**

Races 2, 4, 6, and 8 were taken off the turf due to inclement weather. This constitutes half of today's race card and generated some scratches that will be listed under program changes.
