#### RULING #18 ABEL CEDILLO

The foregoing ruling was issued after Mr. Cedillo and the Stewards reviewed the video of the eighth race from Sunday, November 20, 2016. Mr. Cedillo acknowledged he erred in allowing his mount to drift in soon after the start and impede a rival. That rival, Velocitation (Cristobal Herrera) went on to finish in front of Mr. Cedillo's mount, so disqualification was not necessary.

Mr. Cedillo received a five day suspension as this infraction is his second careless riding violation in the last sixty days.

#### **#18**

Jockey **Abel Cedillo** who rode **One More Roll** in the eighth race at Golden Gate Fields on Sunday, November 20, 2016 is suspended five (5) racing days (December 1, 2, 3, 4, & 8, 2016) for crossing over without sufficient clearance on the backstretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding-second offense in sixty days).

The term of this suspension shall not prohibit participation in designated races in California.

11-24-2016<sup>4</sup> **CLAIM VOIDED-2<sup>ND</sup> RACE**

The Stewards voided the claim submitted by trainer Ari Herbertson for the three year old filly Tribal Thunder (Trainer Andy Mathis) after State Veterinarian Forrest Franklin reported the filly was unsound in the right foreleg. Tribal Thunder was returned to the Mathis barn.
