#### RULING #25-MARIO CISNEROS

Jockey **MARIO CISNEROS** who rode **TROJAN TIME** in the ninth race at Golden Gate Fields on Sunday, November 12, 2017 is fined the sum of One Hundred Dollars (\$100.00) \* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond.

The Stewards met with jockey Mario Cisneros regarding his ride on Trojan Time in the ninth race on Sunday, November 12, 2017.

Mr. Cisneros was very forthright in acknowledging he struck his mount four times inside the 1/8 pole and accepted the penalty imposed.

11-16-2017<sup>4</sup> **RULING #26-CRISTOBAL HERRERA**

Jockey **CRISTOBAL HERRERA** who rode **BOLD CHARMANT** in the first race at Golden Gate Fields on Sunday, November 12, 2017 is fined the sum of One Hundred Dollars (\$100.00) \* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

Jockey Cristobal Herrera and the Stewards reviewed the video of the first race from Sunday, November 12, 2017. Mr. Herrera admitted using his crop more than three times consecutively and accepted the penalty imposed.

The Stewards and jockey William Antongeorgi reviewed the video of the eighth race from Sunday, November 12, 2017. The veteran rider admitted using his crop four times without allowing his mount to respond and accepted the penalty imposed.

Jockey **SILVIO AMADOR** is fined the sum of Fifty Dollars (\$50.00)\* for failure to report to the film review when directed to do so; a violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers).

The above ruling was issued after Mr. Amador appeared and apologized for not showing up yesterday for film review. Mr. Amador said he forgot and accepted the penalty.

Today we reviewed the video of the sixth race from Sunday and Mr. Amador was advised to have more control of his mount when leaving the starting gate.

11-17-2017<sup>4</sup> **OBJECTION-5<sup>TH</sup> RACE-NO CHANGE**

The Stewards posted the objection sign at the request of jockey Abel Cedillo (#2 Mambo Rock-fourth), who lodged a claim of foul against #3 Pepper Magic (Silvio Amador) third.

After a thorough video review and talking with the riders involved, the Stewards decided unanimously to make the original order of finish official, as there was nothing to warrant a disqualification.

11-17-2017<sup>5</sup> **MARE INJURED-6<sup>TH</sup> RACE**

During the running of the sixth race #6 Russian Radiance (GB) (Julien Couton) was injured near the 3/8 pole and was pulled up by Jockey Couton.

Track Veterinarian Sara Sporer, DVM, reported the five year old mare suffered a fractured fetlock in her left foreleg and was euthanized on the track.

Jockey Couton, who complained of soreness in his back and hip, was transported to the track physician's station. Doctor David Seftel, M. D. examined the veteran rider and recommended he go to Alta Bates Hospital for further examination. Mr. Couton was excused from his remaining mounts and will require medical clearance before riding again.

**INQUIRY-DISQUALIFICATION-5<sup>TH</sup> RACE**

The Stewards put up the inquiry sign following the fifth race for a review of an incident near the 1/8 pole involving #5 Silver Jester (William Antongeorgi) fourth and #3 Spanish Eyes (Frank Alvarado) who finished sixth.

After consulting with the patrol judge, talking with the riders involved and reviewing the video of the race, the Stewards decided unanimously to disqualify #5 Silver Jester from fourth to sixth.

The video shows #5 Silver Jester drift out into the path of #3 Spanish eyes, forcing the latter to take up, lose momentum and the opportunity of a better placing.
