BUCKRIDGE**, who started the horse **MISTICAL MELODY**, third place finisher in the first race on November 24, 2017, is fined the sum of One Thousand Dollars (\$1,000.00)\* pursuant to California Horse Racing Board rule #1887 (a) & (d) (Medication, Drugs and Other Substances-Dexamethazone, in excess of permitted level, 504 pg/ml plus Phenylbutazone, 1.03 ug/ml and Flunixin, 19.0 ng/ml [class 4]).

The above ruling was issued after Ms. Buckridge appeared and although unaware of how it occurred, accepted responsibility for the three medications detected in her horse Mistical Melody.
