The above ruling was issued after Mr. Orozco and the Stewards reviewed the video of the fifth race from Saturday, March 3, 2018. Mr. Orozco acknowledged he once again violated the crop rule and was reminded that the penalty continues to increase with a suspension possible.

RULING #63-EVAN S. CRUMP (CASE #18GG0010)

Owner **EVAN S. CRUMP**, having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields on or before March 9, 2018, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility).

During the term of the suspension, all licenses and license privileges of **EVAN S. CRUMP** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises in this jurisdiction.

The above ruling was issued as Mr. Crump, a minor, failed to appear for a scheduled hearing regarding a financial complaint filed against him by San Francisco Equine (Kim Kuhlmann, D.V.M.).

The complaint alleges a past due veterinarian bill (\$721.00). Mr. Crump's parents, Dawn and Anthony were previously suspended for financial issues.

INQUIRY-NO CHANGE-4TH RACE

The Stewards posted the inquiry sign following the fourth race to review an incident near the 3/16 pole involving #3 Mistical Melody (Lucas Gutierrez) third and #4 Marina Delmar (Abel Cedillo) fourth.

The video shows #3 Mistical Melody rush up inside #34 Marina Delmar coming out of the turn approaching the 3/16 pole and clip the heels of the latter. The young apprentice Gutierrez was fortunate to remain in the saddle as a result of this ill advised move. Mr. Gutierrez will meet with the Stewards tomorrow.

The above ruling was issued after Mr. Orozco and the Stewards reviewed the video of the second race from Saturday, March 10, 2018. Mr. Orozco agreed he violated the crop rule by striking his mount four consecutive times after the start.

Apprentice jockey Jose Rodriguez met with the Stewards to explain why he reported his weight at 118 pound when checking in to the Jockey's room and weighed out at 121 pounds prior to the ninth race on Saturday March 10, 2018.

The young rider stated he believed he could lose the weight in the hot box, but obviously weighed more than he thought.

Apprentice jockey Lucas Gutierrez and the Stewards reviewed the video of the fourth race from Saturday March 10, 2018.
