FILM REVIEW

Jockeys Rocco Bowen, Aaron Gryder and Alejandro Gomez visited with the Stewards this morning concerning their rides on last Sunday's card. Bowen was able to point out on the replays where he corrected his mount from drifting out too far in the sixth race and was held blameless.

Gryder, who contacted the Stewards by phone, and Gomez who appeared in person, both admitted they strayed off a straight path and caused interference. The following rulings were issued:

The term of this suspension shall not prohibit participation in designated races in California.

Jockey **ALEJANDRO GOMEZ** who rode **CYLINDERS** in the fifth race at Golden Gate Fields on Sunday, April 1, 2018 is suspended three (3) racing days (April 13, 14 and 15, 2018) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to second; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-careless riding).

The term of this suspension shall not prohibit participation in designated races in California.
