INQUIRY-ACCIDENT-1ST RACE

The Stewards posted the inquiry following the running of the first race for a review of an accident near the 1/8 pole.

The video shows #3 Blackhawk Beauty (Silvio Amador) was injured in the right front leg and fell in front of #2 Amazing Donald (Francisco Duran), who stumbled and fell over the fallen horse. No other horses in the six horse field were affected by the accident.

The initial report from the track physician, David Seftel, M. D., indicated Mr. Amador sustained a broken leg and was transported to Highland Hospital. Mr. Duran was shaken up, but otherwise escaped serious injury.

Blackhawk Beauty (Trainer Jeff Bonde) injured his right front fetlock and was euthanized on the track by the Track Veterinarian Sara Sporer, DVM. Amazing Donald (Trainer J. B. Josephson) got up quickly, ran off and was not seriously injured.

05-11-2018⁴**INQUIRY-ACCIDENT-5TH RACE**

The Stewards conducted an inquiry following the fifth race for a review of the start. The video clearly shows #3 Sierra Steel (Juan Hernandez) stumble and unseat his rider leaving the starting gate. No other horses were involved.

Blackhawk Beauty (Trained by Jeff Bonde) - During the running of the first race on the Tapeta surface, Blackhawk Beauty was injured at the 1/8 pole and was euthanized on the track due to the severity of injury.

Friday May 11, 2018 (Racing Non-Fatal)

Sierra Steel (Trainer Andres Psarras) - Horse stumbled during the running of the 5th race on the Tapeta surface at the break, grabbed a quarter and unseated rider. Horse ran off and rider had no serious injuries.

Friday May 11, 2018 (Racing Non-Fatal)

Amazing Donald (Trainer Jedd Josephson) - Horse fell at the 1/8 pole during the first race on the Tapeta surface, unseated rider and ran off. Neither horse nor rider were seriously injured.
