#### BONNET RULING

##### **#108**

Jockey/exercise rider **CHESTER R. BONNET** is fined the sum of Fifty Dollars (\$50.00)\* for galloping on the rail during training hours on Thursday, May 24, 2018; a violation of California Horse Racing Board rule #1870 (Conditions of Meeting Binding on Licenses).

The above ruling was issued after Bonnet appeared and accepted responsibility for failing to stay off the rail while galloping.

#### OROZCO RULING

##### **#109**

Jockey **IRVING OROZCO** who rode **ANGRY BOBBY** in the ninth race at Golden Gate Fields on Sunday, May 20, 2018 is fined the sum of One Hundred Dollars (\$100.00)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

The above ruling was issued after Orozco appeared and accepted responsibility for using the crop four times in the heat of battle without pausing between strikes.

**FELIX ABSOLVED (REFERENCE 05/20/2018<sup>2</sup>)**

Jockey Chester Bonnet represented Jockey Angel Felix whose mount was disqualified Sunday. After review it was determined that Felix made a good effort to straighten his mount when it ducked in near the 5 ½.

**1<sup>ST</sup> RACE CLAIM VOIDED**

The claim submitted by Trainer D. Wayne Baker for the three year old filly "The Last Rule" was voided after State Veterinarian Forrest Franklin reported she "Bowed" in her right front leg. "The Last Rule" was returned to the barn of Steve Sherman.

**2<sup>ND</sup> RACE INQUIRY-DISQUALIFICATION**

The inquiry sign was posted to review the stretch run concerning first place finisher #1 Ontonome (Ferrin Peterson) and second place finisher #3 Madame Warrior (William Antongeorgi III). After review, talking to the riders involved and a patrol judge report #1 was disqualified from 1<sup>st</sup> to 2<sup>nd</sup> for interference in the stretch. Tapes show #1 comes out in the stretch forcing #3 off its path costing #3 any chance at a better placing.

**PETERSON RULING (REFERENCE 05/24/2018<sup>5</sup>)**

**#110**

Apprentice Jockey **FERRIN PETERSON** who rode **ONTONOME** in the second race at Golden Gate Fields on Thursday, May 24, 2018 is suspended five (5) racing days (June 1, 2, 3, 7, and 8, 2018) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of her mount from first to second; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-careless riding-second offense in 60 days).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Peterson appeared and reviewed the race in question. This was Peterson's second offense in the past sixty days so the penalty increased to five days. Peterson understood that she is expected to make a much better effort to straighten her mount when it starts to drift.

**MOJALLALI HARING (CASE #18GG0035)**

A hearing was conducted concerning an alleged violation of California Horse Racing Board rules #1484, #1485 (d) and #1930 by Owner Sharouz Mojallali. The charges stem from Mr. Mojallali having horses with Trainer Jonathan Wong working at Golden Gate while he was under suspension for failure to appear on

a financial matter. Mr. Mojallali paid the bills after he was notified by his Southern California Trainer that his license was under suspension for failing to appear, according to his testimony. Mr. Mojallali was reinstated in April after satisfying his debts. No horse owned by Mr. Mojallali raced in California during his suspension nor was an order given to remove his horses from the premises. More to come....

The above ruling was issued after Starter Todd Stephens appeared with Assistant Starter Tommy Nelson who was responsible for interfering with #5 Declassified at the start of yesterday's ninth race, which caused Declassified to be declared a non-starter.

**PETERSON RULING (REFERENCE 05/26/2018<sup>3</sup>)**

**#113**

Apprentice Jockey **FERRIN PETERSON** who rode **ENGRAM** in the ninth race at Golden Gate Fields on Saturday, May 26, 2018 is suspended seven (7) racing days (June 9, 10, 15, 16, 17, 21 and 22, 2018) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of her mount from fourth to sixth; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-careless riding-third offense in 60 days).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Peterson appeared and reviewed the race with the Stewards. Unfortunately young Ms. Peterson failed to straighten her mount in a timely manner causing interference result in in a disqualification of her mount from 4<sup>th</sup> to sixth. This is her 3<sup>rd</sup> offense in the last 60 days, thus the severity of the penalty.

**6<sup>TH</sup> RACE INQUIRY-DISQUALIFICATION**

The inquiry sign was posted to review an incident in the stretch involving third place finisher #2 Ambers Ace (Heribert Martinez) and sixth place finisher #4 Lucky Quake (Hugo Herrera). #2 starts to get out in the stretch and is steered back into the path of #4 by Jockey Martinez causing Jockey Herrera to check his mount to avoid clipping heels. #2 was disqualified from 3<sup>rd</sup> and placed sixth for the interference.

During the term of this suspension, all licenses and license privileges of **WILLIAM A. EVANS** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued when Evans failed to appear to answer charges of an alleged \$1,686.58 bill owed to Equine Sports Medicine & Surgery.

05-28-2018<sup>3</sup>**MARTINEZ RULING (REFERENCE 05/27/2018<sup>4</sup>)****#116**

Jockey **HERIBERT MARTINEZ** who rode **AMBERS ACE** in the sixth race at Golden Gate Fields on Sunday, May 27, 2018 is suspended five (5) racing days (June 7, 8, 9, 10 and 15, 2018) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from third to sixth; a violation of California Horse Racing Board rule #1699 (c) & (e) and (Riding Rules-careless riding-second offense in the past 60 days).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Martinez appeared and reviewed the race in question with the Stewards. The majority of the Stewards felt Martinez steered his horse into a rival's path and was late to react to straighten him out. Steward Nevin felt Martinez did a sufficient job of correcting and showing enough effort to avoid penalty.
