09-09-2018¹ **RULING #09-OROZCO**

Jockey, **IRVING OROZCO**, who rode **APPHIA** in the fourth race at Golden Gate Fields on Saturday, September 8, 2018 is fined the sum of One Hundred (\$100.00)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

The above ruling was issued after Orozco contacted the Stewards and accepted responsibility for cropping his mount four consecutive times.

09-09-2018² **STARTER/OUTRIDER MEETING (REFERENCE 09/07/2018¹)**

Director of racing/Racing Secretary Patrick Mackey, Starter Todd Stephens and outrider Ashton Campoy met with the Stewards to fine tune the post parade timing issue. All parties agreed that the first horse will be loaded during the twelfth minute on the track. Any variation could result in penalties being issued.

09-09-2018³ **2ND RACE INJURY**

#3 Daddy Duke was pulled up by Jockey Ricardo Gonzalez near the 1/8 pole. The Isidro Tamayo trainee was taken off the track in the horse ambulance. Reported euthanized.

09-09-2018⁴ **6TH RACE STEWARDS REVIEW**

The Stewards ordered a review of the start of this six furlong event for the public's benefit. The morning line favorite #1 "Beat The Chalk" ducks in sharply as the horses leave the chute onto the main track and jockey Irving Orozco has to take a good hold of him to steer him back to a straight path. Since #1 was not bothered there was no reason for an inquiry.

09-09-2018⁵ **9TH RACE HORSE PULLED UP**

#6 Colour Me Happy(GB) was pulled up after the first 1/16 of a mile of this mile 1/16 turf event by Jockey William Antongeorgi III. Antongeorgi related that Colour Me Happy (GB) was choppy and trying to prop so he thought something was physically wrong. The horse was taken to the Receiving Barn and examined by State Veterinarian Forrest Franklin who released him without placing him on the Veterinarian's List. However, since he did not finish the race Colour Me Happy(GB) will be placed on the Stewards List.
