\$352.4409-15-2018² **RULING #12-WILLIAM J. NOLAN****#12**

Trainer **WILLIAM J. NOLAN**, having shown proof of completion of an in-house rehabilitation program acceptable to the Board of Stewards as required by Oak Tree at Pleasanton ruling #17, dated July 4, 2018 is hereby restored to good standing.

Further, **MR. NOLAN** will continue on probation for the term of his license (12/31//2018). As conditions of probation Mr. Nolan must remain on a testing program for as long as he is licensed by the California Horse Racing Board and abide by the terms of a contract with the Winners Foundation through January 17, 2019.

The foregoing ruling was issued after Mr. Nolan met with the Stewards and provided documents indicating he successfully completed a thirty (30) day in house rehabilitation program. Mr. Nolan was required to enter the program as directed in ruling #17 issued by the Stewards at the Oak Tree at Pleasanton meet on July 4, 2018.

09-15-2018³ **CLAIM VOIDED-3RD RACE**

The Stewards voided the claim submitted by Trainer Andy Mathis for the six year old gelding Macho Gabacho after the Official Veterinarian, Forrest Franklin, DVM, reported

Macho Gabacho bled from the nostrils. Macho Gabacho was returned to Jonathan Wong's barn.

SUNDAY09-16-2018¹ **RULING #13-NATALIE E. HOULE (CASE #18GG0085)****#13**

Trainer **NATALIE E. HOULE**, who started the horse **THE BOLD ONE**, fourth place finisher in the third race at Oak Tree at Pleasanton on June 15, 2018, is fined the sum of One Thousand Dollars (\$1,000.00)*, pursuant to California Horse Racing Board rule #1887 (a) (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1843.1 (b) (Prohibited Drug Substances), #1844 (c) (3) (Authorized Medication), and #1843 (a) & (d) (Medication, Drugs and Other Substances-more than one approved medication-Phenylbutazone (0.68 ug/ml) and Ketoprofen (59.2 ng/ml) in excess of permitted level [Class 4]).

The above ruling was issued after Ms. Houle contacted the Stewards by telephone and requested to waive her right to a hearing and accept responsibility for the double medication finding. Ms. Houle was at a loss regarding the Ketoprofen as she does not use it on her horses.

09-16-2018² **LULLABY'S ORPHAN**

The Stewards met with Trainer Amanda Lockett, trainer of Lullaby's Orphan, who was scratched from the eighth race on September 15, 2018. Also present was former Trainer Jacob Aguilar and his bookkeeper, Cindy Hoskin. Absent was the owner of record Daryl Wright who faxed a statement that was received by the Stewards on the morning of the race, requesting the horse be scratched.

At issue was Ms. Lockett's contention that she is the owner of Lullaby's Orphan by virtue of Mr. Wright's signature on the foal certificate, but was not properly authenticated by a Clerk of the Course or a Board of Stewards. Attempts to contact Mr. Wright were unsuccessful.

Mr. Aguilar's issue an alleged prior training bill owed by Mr. Wright. Lullaby's Orphan will be placed on the Steward's List until such time as the ownership issue is resolved.

09-16-2018³ **STEWARDS REVIEW-6TH RACE**

The Stewards conducted a video review of the start of the sixth race for the wagering public. The video shows #2 Double Tiger (Trainer Jamey Thomas) breaks with the field in this six furlong event and then is quickly pulled up by Jockey Catalino Martinez. Track Veterinarian Sara Sporer, DVM, reported the two year old colt was unsound in the hind end and placed on the Veterinarian's List.
