AUSTIN SOLIS RULING

RULING NO # 7

Jockey **Austin Solis** who rode **Phantom Rendezvous** in the sixth race at Golden Gate Fields on October 21, 2018 is fined the sum of **One Hundred** dollars (**\$100.00**)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

The above ruling was issued after **Mr. Solis** met with the stewards and acknowledged he used his Riding Crop more than three consecutive times in the stretch.

THURSDAY10-25-18³**FILM REVIEW – SECOND AND EIGHTH RACES**

Jockeys **Pedro Terrero** and **Irving Orozco** met with the Stewards to review minor incidents in their respective Races. Both Riders were cautioned about maintaining a straight course.

THURSDAY10-25-18⁴**STEWARDS REVIEW – 4TH RACE**

The Stewards conducted a Video Review of the start of the Fourth for the benefit of the Wagering Public. The Video clearly shows #1 **One Eyed Mama**, ridden by Jockey **Abel Cedillo**, throw her head when the Starting Gate opened and was off to a poor Start. **One Eyed Mama** caused her own problem and was declared a Starter.

FRIDAY10-26-18²**RULING #8 – DAVID MUSSAD** (18GG0105)

Apprentice Jockey **David Mussad** having failed to respond to written notice to appear before the Board of Stewards at Golden Gate Fields or before October 25, 2018, is hereby suspended for violation of California Horse Racing Board rule **#1547** (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule **#1874** (Disorderly Conduct).

During the term of this suspension, all licenses and license privileges of **David Mussad** are suspended and pursuant to California Horse Racing Board rule **#1528** (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

This foregoing Ruling was issued as **Mr. Mussad** failed to appear for a scheduled Hearing to address a complaint alleging a violation of California Horse Racing Board Rule #1874 (Disorderly Conduct – Marijuana).

SATURDAY10-27-18²**RULING #9 – JUAN HERNANDEZ****RULING NO # 9**

Jockey **Juan Hernandez** who rode **Propeppy** in the Eighth race at Golden Gate Fields on Friday October 26, 2018 is fined the sum of **Two Hundred** dollars (**\$200.00**)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop - used more than three times without giving the horse a chance to respond, second offense in last 60 days).

*Rule #1532 - Fine shall be paid to the Paymaster within seven calendar days from the date of this ruling or the License of the person upon whom the fine has been imposed shall be suspended.

The above Ruling was issued after **Mr. Hernandez** met with the Stewards and acknowledged he violated the crop Rule.

SATURDAY10-27-2018³**RULING #10 – KEVIN OROZCO****RULING NO # 10**

Jockey **Kevin Orozco** who rode **Blessed Lady** in the eighth race at Golden Gate Fields on October 26, 2018 is fined the sum of **One Hundred dollars (\$100.00)*** for violation of California Horse Racing Board rule #1688 (use of Riding Crop - used more than three times without giving the horse a chance to respond).

Mr. Orozco met with the Stewards, readily admitted he violated the crop Rule and was advised the above Ruling would be issued.

*Rule #1532 – Fine shall be paid to the Paymaster within seven calendar days from the date of this ruling or the License of the person upon whom the fine has been imposed shall be suspended.

RULING #11 JOSE VALDIVIA JR.

RULING NO # 11

Jockey **Jose Valdivia Jr.** is fined the sum of **Three Hundred dollars (\$300.00)*** for failure to ride his mounts on October 25, 26, and 27, 2018; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

*Rule #1532-Fine shall be paid to the Paymaster within seven calendar days from the date of this ruling or the license of the person upon whom the fine has been imposed shall be suspended.

The foregoing Ruling was issued as **Mr. Valdivia** notified the stewards he was relocating and would not be available to fulfill his engagements.

INQUIRY – ACCIDENT 3RD RACE

The Stewards posted the Inquiry sign following the Third Race for a review of an accident approaching the 3/16 pole. The video shows #4 **Pamplmiss (Irving Orozco)** appear to clip heels with #2 **Song Of Thorns (Cristobal Herrera)** stumble and unseat Jockey **Orozco**. The video was inconclusive as to whether #2 **Song Of Thorns** stepped out or #4 **Pamplmiss** stepped in causing the accident.

Jockey **Orozco**, who appeared to be struck by two trailing horses was immediately attended to by the ambulance staff. The initial report indicated possibly internal injuries and he was transported to Highland Hospital. Albany Fire Ambulance service transported **Mr. Orozco** and because of his injury they did not transfer him to their Backboard, which left the Track Ambulance without their Backboard and Oxygen.

The accident and the search to replenish the Ambulance Equipment resulted in a twenty minute delay for Race #Four.

INQUIRY – DISQUALIFICATION – 4TH RACE

The Stewards posted the Inquiry sign following the Fourth Race for a review of an incident inside the 1/16th pole. After considering the Patrol Judge report interviewing the riders involved and reviewing the video, the Stewards decided unanimously to disqualify #6 **Alleycat (Pedro Terrero)** from Third to Fifth place for causing interference. The Video shows #6 Alleycat swing out from behind the leaders and into the path of #4 **Thorn Hill Cat (Herbert Martinez)** forcing the latter to take back and lose the opportunity of a better placing.

RULING NO #12

Veterinarian **Dr. Kim L. Kuhlmann** is fined the sum of **Two Hundred** dollars (\$200.00)* for violation of California Horse Racing Board rule #1864 (Labeling of Medications) on August 31, 2018.

The foregoing Ruling was issued after **Kim Kuhlmann, DVM** met with the Stewards regarding the complaint filed against him for insufficient labeling on permitted medications found in Trainer **Gary Greiner's** Tack Room.

Dr. Kuhlmann did not dispute the accusation and indicated that more information would be included on the label in the future.

*Rule #1532-Fine shall be paid to the Paymaster within seven calendar days from the date of this ruling or the license of the person upon whom the fine has been imposed shall be suspended.

RULING #13 PEDRO TERRERO

RULING NO # 13

Jockey **Pedro Terrero** who rode **Alleycat** in the fourth race at Golden Gate Fields on October 27, 2018 is suspended Three (3) racing days November 4, 8, and 9, 2018 for altering course without sufficient clearance in the stretch and causing interference resulting in the disqualification of his mount from third to fifth a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules - Careless Riding).

The term of this suspension shall not prohibit participation in in designated races in California.

The Stewards issued the above Ruling after Jockey **Pedro Terrero** appeared for a review of the Fourth Race from Saturday, October 27, 2018.

Mr. Terrero acknowledging he errored when altering his course into the path of a rival and causing interference.
