**FRIDAY**11-9-18<sup>1</sup>**CEDILLO RULING****RULING NO # 17**

Jockey **Abel Cedillo** who rode **American Royalty** in the fourth race at Golden Gate Fields on November 8, 2018 is fined the sum of Two Hundred dollars (\$200.00)\* for violation of California Horse Racing Board rule #1688 (use of Riding Crop - used more than three times without giving the horse a chance to respond - second offense in sixty days).

The above Ruling was issued after **Cedillo** appeared and reviewed the Race in question. He understood our stance that he did not give the horse a chance to respond to his use of the crop.

11-9-18<sup>2</sup>**PEDRO FLORES RULING****RULING NO # 18**

Jockey **Pedro Flores** who rode **Red City Zip** in the fourth race at Golden Gate Field's on November 8, 2018 is fined the sum of One Hundred dollars (\$100.00)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop - used more than three times without giving the horse a chance to respond)

The above Ruling was issued after **Pedro** reviewed the Race with the Stewards and realized he cropped the Horse four times without pausing.

11-9-18<sup>3</sup>**RACE DELAY**

Post time was delayed ½ hour due to a power outage. Emergency Generators failed to engage prior to the First Race. Management assured the Stewards the Generators would be working as soon as new Batteries could be put into action. In order to make sure enough time was given to replace the Batteries it was agreed to move first post from 12:45pm to 1:15pm. All personnel and the public were informed of the delay and no further problems arose.

**SATURDAY**11-10-18<sup>1</sup> **ALLISON RULING CASE 18SW0029****RULING NO # 19**

Veterinarian **Kenneth C. Allison** is fined the sum of **Two Hundred** dollars (**\$200.00**)\* for violation of California Horse Racing Board rule #1864 (Labeling of Medications) on October 5, 2018.

The above Ruling was issued after **Dr. Allison** came in and apologized for not finishing the labeling on a prescription issued at Fresno. He stated that the workload was excessive at Fresno and he dropped off the Medication without writing the horses name down.

11-10-18<sup>2</sup> **GONZALEZ RULING****RULING NO # 20**

Jockey **Edwin O. Gonzalez** is fined the sum of **Two Hundred** dollars (**\$200.00**)\* for failure to ride his mounts on November 8 and 9, 2018; a violation of California Horse Racing Board Rule #1872 (Failure to Fulfill Jockey Agreement).

The above Ruling was issued when Gonzalez left town and never told his Agent or the Racing Office or the Stewards.

11-10-18<sup>3</sup> **PEDRO FLORES RULING****RULING NO # 21**

Jockey **Pedro Flores** who rode **Hot N Breezy** in the first race at Golden Gate Field's on November 9, 2018 is fined the sum of **Two Hundred** dollars (**\$200.00**)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop; used more than three times without giving the horse a chance to respond - Second Offense in Sixty Days).

The above ruling was issued after **Flores** appeared for the Second day in a row on a Crop violation. He said he lost count while vying for the lead.

11-10-18<sup>4</sup> **HERNANDEZ RULING****RULING NO #22**

Jockey **Juan Hernandez** who rode **Sunrise Journey** in the Fourth race at Golden Gate Fields on November 9, 2018 is fined the sum of **Three Hundred** dollars (**\$300.00**)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop - used more than three times without giving the horse a chance to respond, third offense in last 60 days

The above Ruling was issued after Jockey **Hernandez** appeared and took responsibility for one too many strikes with the crop while winning the Race.

 Jockey **Kevin Orozco** aboard #1 **Skeeter Davis** (5<sup>th</sup>) lodged a claim of foul against the winner #2 **Music Babe** and Jockey **Julien Couton** for alleged interference near the 3/16<sup>th</sup> pole on the Turf. In a unanimous opinion the Stewards voted to make no change. #1 appeared to be getting out on its own and #2 did not come in taking its path as alleged.

- Jockey **Abel Cedillo** who rode **Gig's Lil' Gal** in the First race at Golden Gate Fields on November 10, 2018 is fined the sum of **Three Hundred dollars (\$300.00)\*** for violation of California Horse Racing Board rule #1688 (Use of Riding Crop - used more than three times without giving the horse a chance to respond - Third offense in last sixty days).
- The above Ruling was issued after Jockey **Cedillo** appeared again this week for violating the crop rule. He had no real explanation but assured us he would change his ways to avoid further penalties.

 Trainer **Monte Meier** was issued a warning for being argumentative to Security while being asked to display his California Horse Racing Board License in the Paddock area.
