RULING # 25 PEDRO TERRERO (REFER 11-11-18⁶)

RULING NO # 25

Jockey **Pedro Terrero** who rode **Shadrack** in the Fourth Race at Golden Gate Fields on November 11, 2018 is suspended seven (7) racing days (November 22, 23, 24, 25, 29, 30, and December 1st, 2018) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to unplaced; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules - Careless Riding). The term of this suspension shall not prohibit participation in designated races in California.

The above Ruling was issued after **Mr. Terrero** and the Stewards reviewed the video of the Fourth Race from November 11, 2018.

Mr. Terrero's mount was disqualified from first to unplaced for interference in the stretch. The veteran riders mount bore in throughout the stretch and in the majority opinion (**Herbiveaux** dissenting) **Mr. Terrero** failed to make the effort necessary to correct his mount resulting in a fellow rider being dislodged and falling from his mount.

11-15-18³**PAUL PLANCHON (18GG0139)**

Owner **Paul Planchon** appeared as requested to address a Golden Gate Security complaint regarding his failure to display his license while attempting to enter the Paddock to view the saddling of his horse. **Mr. Planchon** produced his license and was still denied entry because he refused to display the license around his neck with the use of a lanyard.
Complaint Dismissed.

11-16-18²**RULING #26 – J.C. SELVESTER****RULING NO # 26**

Trainer **J.C. Selvester** is fined the sum of three hundred dollars (\$300.00)* for violation of California Horse Racing Board rule #1501 (Worker's Compensation Insurance Required) on November 15, 2018 necessitating a late declaration for the horse **Latin Charm** in the fifth race at **Golden Gate Fields**.

The foregoing Ruling was issued after **Mr. Selvester** was informed of the penalty for a late declaration. **Mr. Selvester's** Workers Compensation Policy begins today November 16, 2018.

11-16-18³**JACOB G. AGUILAR – (18GG0138)**

Trainer **Jacob Aguilar** met with the Stewards regarding the complaint filed against him by Golden Gate Fields Security.

Mr. Aguilar was stopped from entering the paddock on his way to saddle a horse and did not have his California Horse Racing Board license with him. **Mr. Aguilar** then went to an unsecured entrance to the paddock and proceeded to saddle his horse.
