11-28-18¹ ENTRIES FOR SATURDAY

Steward **John Herbuveaux** was on hand to handle transfers etc. for Saturday's entries.

11-29-18¹ MUSSAD REINSTATED

RULING NO #28

Apprentice Jockey **David Mussad** having now appeared and a hearing having been held is hereby restored to good standing and Pacific Racing Association Ruling #8, dated October 26, 2018, suspending **Mr. Mussad** for violation of California Horse Racing Board rule #1547 (Failure to Appear) is set aside.

Further, **David Mussad** is fined One Hundred Dollars (\$100.00)* and placed on probation for the term of his license (11/30/2020) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct - use of Marijuana) on August 30, 2018. Conditions of probation include adherence to a signed Testing Agreement with the California Horse Racing Board.

The above ruling was issued after **Mr. Mussad** produced a clean test.

11-29-18² SHELLY RULING REF (11-25-18³)

RULING NO #29

Trainer **Helen Shelly** is fined the sum of Two Hundred Dollars (\$200.00)* for possession of unlabeled prescription medication at her barn on October 5, 2018; a violation of California Horse Racing Board rule #1890(b) (Possession of Contraband).

The above Ruling was issued after due deliberation over Sundays Hearing. **Ms. Shelly** understood that all prescribed medications need to be properly labeled.

11-29-18³ **DISQUALIFICATION RULING CASE 18GG0144 (REF. 11/24/18²)**

RULING NO #30

Acting on a report from the University of California at Davis Maddy Laboratories, the official laboratory for the California Horse Racing Board, that the postrace urine sample #GG31679, taken from horse **One Son Of A Chief**, second place finisher in the ninth race at Golden Gate Fields on September 30, 2018, contained the prohibited substance **Clenbuterol** in excess of the permitted level (204 pg/mg) it is hereby ordered that **One Son Of A Chief** be disqualified from all purse monies earned and deemed unplaced in accordance with California Horse Racing Board rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that all purse monies **\$3,600.00** earned or awarded to owner **Melani Navarrete** Trainer **Jerry R. Puertas** and Jockey **Pedro Terrero** be returned to the Paymaster of Purses on or before December 10, 2018 for redistribution pursuant to California Horse Racing Board rule #1760 (Purse Award or Prize to be Withheld).

All records are ordered changed to reflect this ruling. In accordance with California Horse Racing Board rule #1956 (Race Declared Official), this ruling shall not affect the Pari – Mutuel payoffs.

The above Ruling was issued as a result of the Positive Test Hearing which concluded that **"One Son Of A Chief"** tested positive for **Clenbuterol** on September 30, 2018.

11-29-18⁴ **OFF TURF**

The 4th Race was moved from a mile on the Turf Course to the main Tapeta Track surface at a mile due to continuing rain.

11-29-18⁵ **6TH RACE LATE SCRATCH**

#7 **Zambora** trained by **Greg James** arrived in the paddock without hind shoes. This fact was not noted on the Entry blank, Overnight or Program. **Mr. James** was contacted and had no explanation. It was too late to put shoes on and the horse was scratched per California Horse Racing Board Rule #1853 (examination required).

11-30-18¹ **KEVIN OROZCO RULING**

RULING NO # 31

Jockey **Kevin Orozco** who rode **Blessed Lady** in the seventh race at Golden Gate Fields on November 25, 2018 is fined the sum of **Two Hundred dollars (\$200.00)*** for violation of California Horse Racing Board rule #1688 (use of Riding Crop - used more than three times without giving the horse a chance to respond - second offense in the past 60 days).

*Rule 1532 - Fine shall be paid to the Paymaster within seven calendar days from the date of this ruling or the license of the person upon the fine has been imposed shall be suspended.

The above Ruling was issued after **Orozco** contacted the Stewards and waived his right to a hearing and accepted the penalty.

11-30-18² **OCASIO RULING**

RULING NO # 32

Jockey **Luis M. Ocasio** who rode **Cherokee In Me** in the fifth race at Golden Gate Fields on November 29, 2018 is fined the sum of **One Hundred dollars (\$100.00)*** for violation of California Horse Racing Board rule #1688 (use of Riding Crop - used more than three times without giving the horse a chance to respond).

*Rule 1532 - Fine shall be paid to the Paymaster within seven calendar days from the date of this ruling or the license of the person upon the fine has been imposed shall be suspended.

The above ruling was issued after **Mr. Ocasio** appeared and reviewed the race in question. He said he just lost track while using the crop four consecutive times.

11-30-18³ **1ST RACE STEWARDS REVIEW**

The Stewards ordered a review of the start of the first race in which #2 **Thorn Hill Cat** (Tr. **Anthony Stabile**) turned its head at the start and broke three lengths last. After review it was determined that #2 created its own problem and there was no need for an Inquiry.

11-30-18⁴ **4TH RACE CLAIM VOID**

The claim submitted by Trainer **Jonathon Wong** for the filly "**Easy Peasy**" was deemed void after State Veterinarian **Forrest Franklin** reported her lame in the left hind leg. "**Easy Peasy**" was returned to the barn of **Matthew Troy**.

12-1-18¹ **JAMES RULING (REF 11/29/18⁵)**

RULING NO # 33

Trainer **Greg James** is fined the sum of Three Hundred Dollars (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty For Late Declaration) for failure to have the horse **Zambora** properly shod necessitating a late scratch in the sixth race on November 29, 2018; a violation of California Horse Racing Board rule # 1853 (Examination Required).

*Rule #1532-Fine shall be paid to the Paymaster within seven calendar days from the date of this ruling or the license of the person upon whom the fine has been imposed shall be suspended.

The above Ruling was issued after **James** was contacted and accepted the penalty. He stated that he intended to run without Shoes but forgot to tell the Jockey Agent who entered the Horse for him.

12-1-18²**4TH RACE CLAIM VOID**

The claim deposited by Trainer **Jerry Hollendorfer** for the filly "**Hardsense**" was deemed void when State Veterinarian **Forest Franklin** reported her off in her RIGHT Front Leg. "**Hardsense**" was returned to the barn of **Tim McCanna**.

12-1-18³**4TH RACE LATE SCRATCH**

#7 "**Lil Ms. Phyllis**" (Tr. **Andreas Psarras**) Flipped in the gate and was declared on the recommendation of track veterinarian **Bill Grantham**.

12-1-18⁴**4TH RACE INQUIRY – NO CHANGE**

The Inquiry Sign was posted to review an incident in the stretch involving third place finisher #3 "**Someday Special**" (**Kevin Orozco**) and fourth place finisher #2 "**Please Zip It**" (**William Antongeorgi III**) in the deep stretch. #3 comes in slightly in the stretch causing Jockey **Antongeorgi** to check slightly while fading from third to fourth. The incident was deemed minor in nature and no change was the unanimous decision.

12-1-18⁵**8TH RACE INQUIRY – DISQUALIFICATION**

The inquiry sign was posted to review two incidents in the stretch drive of this twelve horse event.

Incident #1: At the top of the stretch #8 **Perla Rose (Cristobal Herrera)** comes out into the path of #10 **Secret Wind (Heribert Martinez)** causing Jockey **Martinez** to check his mount sharply losing all momentum. #8 goes on to run third and #10 runs twelfth.

Incident #2: Second place finisher #7 "**Babe Didrikson**" (**William Antongeorgi**) drifts inward in deep stretch causing #9 **My Three Kids (Julien Couton)** to check slightly.

#8 was disqualified and placed last for the first incident. There was no action taken on the second incident.

Sunday12-2-18¹**HERRERA RULING REF 12-1-18⁵****RULING NO #34**

Jockey **Cristobal Herrera** who rode **Perla Rose** in the eighth race at Golden Gate Fields on December 1, 2018 is suspended three (3) racing days December 9, 26 and 28, 2018 for altering course without sufficient clearance entering the stretch and causing interference resulting in the disqualification of his mount from third to twelfth; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules - Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above Ruling was issued after **Herrera** appeared and reviewed the race in question. He realized that he should have made a better effort to try and avoid interfering with another rival. He accepted the Ruling without argument.

12-2-18²**OROZCO WARNING (REF 12-1-18)**

Jockey **Kevin Orozco** was in to review his ride aboard #3 **Someday Special** in yesterday's fourth race in which he survived an inquiry. The majority felt the horse was mainly to blame for the incident. Steward **Nevin** felt days were in order.

As the horses were pulling up after the Ninth Race #10 "**Aigle**" ducked out unseating Jockey **Abel Cedillo**. Jockey **Cedillo** was checked by **Dr. David Seftel** who recommended he not ride the last race due to some bruising. **Cedillo** was replaced in the tenth by **Pedro Terrero**.

12-2-18⁶**10TH RACE CLAIM VOIDED**

The claim submitted by **Tim McCanna** for the Gelding "**Kopitar**" was deemed void when State Veterinarian **Forrest Franklin** reported him sore in his front legs, "**Kopitar**" was returned to the barn of **Bill Delia**.
