Jockey **Juan J. Hernandez** who rode **Singapore Tune** in the fourth race at Golden Gate Fields on January 1, 2019 is fined the sum of **Two Hundred dollars (\$200.00)*** for violation of California Horse Racing Board rule #1688 (Use of Riding Crop - used more than three times without giving the horse a chance to respond, Second offense in past 60 days).

The above ruling was issued after Hernandez contacted the Stewards and plead guilty to excessive cropping. His last offense was November 9, 2018 concerning repeat offenses inside the sixty day timeline.
