SUNDAY1-20-19¹**BAUTISTA RULING (CASE #18GG0146)****RULING NO # 18**

Trainer **Jose G. Bautista**, who started the horse **Dynamite Ride**, winner of the first race at **Golden Gate Fields** on November 3, 2018, is fined the sum of **five hundred** dollars (**\$500.00**)*, pursuant to California Horse Racing Board rule #1887 (Trainer To Insure Condition of Horse) for violation of California Horse Racing Board Rule #1843 (a) & (d) (Medication, Drugs and Other Substances; 4 - **Methylaminoantipyrine** [Class 4]).

The above Ruling was issued following an informal hearing. **Bautista** appeared and stated he did not contest the findings from the lab but had no idea how the substance came to be in the horse's system. Many theories were discussed but no definitive cause was determined to help **Bautista** prevent a recurrence.

1-20-19²**CANTRELL RULING****RULING NO # 19**

Trainer **Margie A. Cantrell** is fined the sum of **six hundred** dollars (**\$600.00**)* pursuant to California Horse Racing Board rule #1629 (Penalty For Late Declaration) for failure to have the horses **Cold Brew Kid** and **Canada** on the grounds necessitating late scratches in the sixth and seventh races on Friday, January 18, 2019; a violation of California Horse Racing Board rule #1698 (Failure To Start And Run).

The above ruling was released after **Ms. Cantrell** contacted the Stewards by phone and related that she couldn't secure the services of a van company to ship the horses up for the races. She was told that inquiries about van availability should have been made prior to entry time and as trainer she was responsible for those arrangements.
