KEVIN OROZCO RULING

RULING NO # 31

Jockey **Kevin Orozco** who rode **Racing Ray** in the Third race at **Golden Gate Fields** on February 3rd, 2019 is fined the sum of **Two Hundred dollars (\$200.00)*** for violation of

California Horse Racing Board rule #1688 (Use if Riding Crop - used more than three times without giving the horse a chance to respond, second offense in the last sixty days).

The above Ruling was issued after Jockey **Orozco** agreed that he mis-used the crop.

OCASIO RULING

RULING NO # 32

Jockey **Luis Ocasio**, who rode **Mombacho** in the eighth race at **Golden Gate Fields** on Sunday, February 3, 2019 is suspended for **Ten (10)** racing days (**February 14, 15, 16, 17, 18, 22, 23, 24, 28 and March 1, 2019**) for altering course without sufficient clearance and causing interference on the far turn resulting in the disqualification of his mount from sixth to unplaced, a violation of California Horse Racing Board rule #1699 (c) (e) (Riding Rules - Careless Riding). The term of this suspension shall not prohibit participation in designated races in California.

After viewing video with the Stewards, Jockey **Ocasio** agreed that his actions resulted in the chain reaction that caused jockey Pedro Flores to be unseated, therefore the above ruling was issued.

CHESTER BONNET RULING

RULING NO # 33

Jockey **Chester Bonnet** is fined the sum of **One Hundred Fifty Dollars (\$150.00)** for reporting late to the jockey's room on Sunday, January 27, 2019 and failing to appear at the steward's office on January 31, 2019 as requested. A violation of California Horse Racing Board Rule #1680 (Jockeys and Drivers to report) and #1930 (Obedience to Security Officers and Public Safety Officers).

Jockey **Bonnet** met with this panel to discuss his tardiness in reporting to the room and to meet with the Stewards as ordered. The above ruling was issued after deliberation.

RULING NO # 34

Trainer **Jonathan Wong**, who started the horse **Amers**, winner of the second race at **Santa Anita Park** on **December 26, 2018**, is fined the sum of **Five Hundred Dollars (\$500.00)***, pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1843 (a) & (d) (Medication, Drugs and Other Substances **Triamcinolone Acetonide**, in excess of permitted level, 233_{pg/ml}, [Class 4], #1843.1 (b) (prohibited Drug Substances) and #1844 (f) (13) (Authorized Medication).

Trainer **Jonathan Wong** met with this panel to discuss Case #19SA0018. After deliberations the above ruling was produced.

The above ruling was published after jockey **Monroy** spoke with the stewards and admitting guilt to being late to the paddock.

2-9-19³**ANTONGEORGI RULING #36****RULING NO # 36**

Jockey **William Antongeorgi** who rode **Tiz Seeking A Win** in the sixth race at **Golden Gate Fields** on **February 8, 2019** is fined the sum of **One Hundred Dollars (\$100.00)*** for violation of California Horse Racing Board rule #1688 (Use of Riding Crop - used more than three times without giving the horse a chance to respond).

Jockey **Antongeorgi** contacted this board by phone admitting mis-use of the riding crop and stating he would accept the penalty.

2-9-19⁴**HENRY FILM REVIEW**

Jockey **Wesley Henry** reviewed the start of the previous day's 5th race with this board of stewards. He was warned that he should re-act faster in an attempt to straighten out his mount while leaving the starting barrier.

2-9-19⁵**FORMAL HEARING:**

A formal hearing was held this morning in response to Complaint 19GG0006 against trainer **Samuel Calvario**. This panel will discuss the issue and weigh the evidence prior to drawing to a conclusion.

2-9-19⁶**RACE 1 SCRATCH**

#1, "**Candy's Martini**", threw his right front shoe during post parade. The gelding was sent to paddock to have it replaced. Unable to safely, and in a timely manner reset the shoe, the horse was scratched by the stewards.

2-9-19⁷**RACE 7 – LATE SCRATCH**

#1, **Coronado Cool**, was a late steward's scratch. The trainer has a recent ruling which included a fine being paid within seven days. The fine was not paid; therefore, the license was suspended.

Jockey **Frank Alvarado** reviewed video of the previous day's 3rd Race with the stewards. Actions in deep stretch were the center of attention. A penalty was not warranted, but caution was advised.

2-10-19³**Calvario Ruling****RULING NO # 37**

Trainer **Samuel M. Calvario**, who started the horse **Giant Mark**, first place finisher in the third race at **Golden Gate Fields** on **December 28, 2018**, is fined the sum of **One Thousand, Five Hundred Dollars (\$1,500)*** pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (A & D) (Medication, Drugs and Other Substances): **Flumethasone** [Class IV] and 1843.1 (A) (Prohibited Drug Substances) (Second offense in 365 days).

The above ruling was issued after deliberation over the previous day's hearing.

2-10-19⁴**VOIDED CLAIM 4TH RACE**

The claim for "**Holdthismiss**" was voided after this seven year old was added to the "Vet's List" as unsound. The gelding remains in the care of trainer **Jerry Hollendorfer**.

2-10-19⁵**8TH RACE INQUIRY/ DISQUALIFICATION**

The stewards ordered the "Inquiry" sign lit to examine actions in the deep stretch after observing the #7 "**The Spiral Jetter**" steady and check. After review, it was determined #4 "**Top Notch**", the original fifth place finisher, drifted into the path of #7 "**The Spiral Jetter**" causing him to lose action.
