RACING CANCELLED

Excessively heavy rains overwhelmed the pumps that drain the swales on the inside of the track compromising the Tapeta drainage system in the stretch. The surface was bladed and rather than risk any problems, track management decided to cancel and take today to get the track surface in good shape. As an aside; Barns 81, 82, 91 and 92 suffered moderate flooding.

CARDENAS RULING REF (2/10/19⁵)

RULING NO # 38

Jockey **Dick Cardenas** who rode **Top Notch** in the 8TH race at **Golden Gate Fields** on **Sunday, February 10, 2019** is suspended **Three** racing days (**February 22, 23 and 24**) for altering course without sufficient clearance in the stretch and causing interference, resulting in the disqualification of his mount from fifth to eighth, a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules - Careless Riding).

The above Ruling was issued after **Cardenas** appeared and reviewed the race with the Stewards. **Mr. Cardenas** accepted that he put a rival at risk of clipping heels and took the penalty without argument.

2-15-19²**CLAIM VOIDED – 1ST RACE**

The claim submitted by Trainer **Cliff DeLima** for the gelding **Barton Lodge** was deemed void by the Board of Stewards when State Veterinarian **Forest Franklin** declared him sore in his front legs. **Barton Lodge** was returned to the barn of **Jonathan Wong**.

The Stewards met with the Jockeys to remind everyone of safety concerns. Specifically we reminded them to take a look before changing lanes and to make sure they have a clear path when they ask their horse to run at the top of the stretch.

2-16-19²**FIRST RACE INQUIRY – NO CHANGE**

The Stewards posted the inquiry sign to review the stretch drive concerning second place finisher #4 **Bounty Hunter (William Antongeorgi)** and third place finisher #5 **Bills Smokn Bullet (Franklin Ceballos)**. After reviewing the race and talking to the riders, no change was made. Tapes show #4 drifting out under left handed urging and #5 changes leads and steps in at the same time near the 1/16 pole where they bump. The contact was deemed mutual but Jockey **Antongeorgi** will visit the Stewards to review his effort.

The Stewards reviewed the start of the 5TH Race for the benefit of the public. #3 "**Dancing Sunset**" threw its head and reared slightly as the field was dispatched by Starter **Todd Stephens** causing its own problem. No reason was found to post the Inquiry sign.

INQUIRY 8th Race – DISQUALIFICATION

The Inquiry sign was posted to review the stretch drive concerning #4 "No New Friends" (Catalino Martinez 5TH), #6 "Spirited Guy" (Alejandro Gomez 7TH) and #3 " Wild Whiskey" (William Antongeorgi 9TH). After review and talking to the riders #4 was unanimously disqualified from fifth and placed seventh behind the #6 for interference in the stretch. Films show #4 bearing in causing Jockey Gomez aboard #6 to steady his mount which in turn caused Antongeorgi to steady slightly on #3 which was a tiring horse. #6 Was cost a chance at a better placing.
