RULING #69 – WILLIAM E. MOREY (REFER 3-31-19¹)

RULING NO # 69

Trainer **William E. Morey** is fined the sum of **Twelve Hundred Dollars (\$1,200.00)*** pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to start the horses **Apalachee Bay, Sound Logic, Moonlight Blue and Mantracker** necessitating late scratches in the sixth and eighth races on **Saturday, March 30, 2019** and second and fifth races on **Sunday, March 31, 2019**; a violation of California Horse Racing Board rule #1698 (Failure to Start and Run).

The above Ruling was issued after **Mr. Morey** was advised of the penalty for not starting the four horses that were scheduled to run on **Saturday, March 30, 2019** and **Sunday, March 31, 2019**.

4-4-19³ **RULING #70 – FRANCISCO MONROY****RULING NO # 70**

Jockey Francisco Monroy who rode **Badger Boy** in the first race at **Golden Gate Fields** on **Sunday, March 31, 2019** is suspended **three (3)** racing days (**April 12, 13 & 14, 2019**) for failure to make a proper effort to maintain a straight course in the stretch and causing interference; A violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules- Careless Riding).

The foregoing Ruling was issued after **Mr. Monroy** and the Stewards reviewed the video of the first race from **Sunday, March 31, 2019**. **Mr. Monroy** acknowledged it was his error in allowing his mount to drift in and cause interference.

Mr. Calvario was at a loss to explain the double treatment, other than the fact that his horses are not all stabled in the same barn and perhaps "**Giant Mark** received the **Flunixin** intended for another horse. Decision pending.

4-5-19³ **STEWARDS REVIEW – 7TH RACE**

The Stewards conducted a video review of the start of the seventh race for the benefit of the wagering public. The video shows #3 **Charlie Cowden (Frank Alvarado)** lift his head as the stall doors opened and get off to a poor start. **Charlie Cowden** caused his own problem and was declared a starter.

4-6-19²**RULING #71 – SAMUEL M. CALVARIO (19GG0043)****RULING NO # 71**

Trainer **Samuel M. Calvario**, who started the horse **Giant Mark**, third place finisher, in the sixth race at **Golden Gate Fields** on **February 10, 2019**, is fined the sum of **Twenty-Five Hundred Dollars (\$2,500.00)***, pursuant to California Horse Racing Board rule #1887 (Trainer or Owner to Insure Condition of Horse) for violation of California Horse Racing Board rules #1843 (a) & (d) (Medication, Drugs and Other Substances - More than one approved medication; **Phenylbutazone 0.92 UG/ML** and **Flunixin 5.3 UG/ML [Class 4]**; third offense in 365 days) and # 1844 (c) (Authorized Medication).

The above Ruling was issued after the Stewards considered the evidence and testimony presented at the hearing held on **April 5, 2019**.

4-6-19³**EQUINE HERPES VIRUS UPDATE (REFER 3-26-19¹)**

California Department of Food and Agriculture Veterinarian **Kathryn Flynn, DVM**, notified Safety Steward **Richard Lewis** that she has terminated the Quarantine of Trainer **Blaine Wright's** barn. **Dr. Flynn** noted there was no evidence of any horses detected, other than the three year old filly **Montana Sunset**, who was euthanized and tested positive for **EHY-IN**.

4-6-19⁴**JOSE BALENZUELA PUENTES (19GG0058)**

Owner/Trainer **Jose B. Puentes** met with the Stewards in response to a complaint filed against him by Golden Gate Fields Security for failing to show his California Horse Racing Board license to Security following a race. **Mr. Puentes** eventually showed his license after unsaddling his horse. Warning Issued. Steward **Herbuveaux** opined a fine was warranted.
