OPENING DAY

Other than the standard opening day issues associated with racing returning to a venue after a four-month absence, all business was routine.

INQUIRY/DISQUALIFICATION

The stewards posted the inquiry sign following the running of the fifth race to examine an incident in the stretch in which #7 Kalookan Lessie, ridden by Tyler Baze clips heels with #2 Tizthen, ridden by Martin Garcia. The horses finished eighth and seventh respectively. After speaking with the patrol judges and riders involved, and reviewing the video tapes, the Stewards determined that #2 Tizthen raced erratically in the stretch, crossing in front of #7 Kalookan Lessie, causing that rival to clip heels. The Stewards therefore voted unanimously to disqualify #2 Tizthen from seventh and place her eighth.

KRUG HEARING

Exercise rider ERIK KRUG met with the Stewards in an informal hearing to discuss case number 07SA143, which involved alleged disorderly conduct and a subsequent cocaine

positive. Mr. Krug was suspended at Oak Tree for failure to appear to address this complaint. Although claiming that he has never done cocaine, Mr. Krug brought Bob Fletcher from the Winner’s Foundation, and was frankly willing to accept any penalty the Stewards believed appropriate. Although Mr. Krug offered several explanations, he refreshingly offered no excuses. The Stewards asked Mr. Krug to sign a testing agreement with the CHRB and requested a test today. Decision to follow.

Jockey JAMES VAIL failed to fulfill his riding assignment in last night’s ninth race because he had other mounts at Los Alamitos. He called to inform the Stewards of the

conflict yesterday afternoon. The Stewards explained that these conflicts must be resolved by scratch time and that therefore a fine was going to be levied:

Jockey JAMES VAIL is fined the sum of one hundred dollars (\$100.00)* for violation of California Horse Racing Board Rule #1872 (Failure to Fulfill Jockey Agreement) on Friday, November 9, 2007.

JENSEN RULING

Having been informed by the CHRB investigative staff that owner/trainer DANIEL JENSEN had satisfied his financial obligation to the Southern California Equine Foundation, the Stewards issued the following ruling reinstating Mr. Jensen's license:

KRUG ADJUDICATION

After deliberating with respect to case number 07SA143 regarding exercise rider ERIK KRUG, the Stewards issued the following two rulings:

In the Matter of:

Exercise Rider ERIK ALAN KRUG

Having now appeared at a hearing to address 07SA143, Erik Alan Krug is restored to good standing and Oak Tree Racing Association ruling #017 dated October 17, 2007 suspending Mr. Krug for violation of California Horse Racing Board rule #1547 (Failure to Appear) is set aside.

California

HRTH #4

Exercise Rider ERIK ALAN KRUG is suspended forty five (45) days, November 11, 2007 through December 25, 2007 and placed on probation for the term of his license (06/2009) for violation of California Horse Racing Board rules 1489 (h) (Grounds for Denial or Refusal of license – Cocaine) and 1874 (Disorderly Conduct).

As a condition of reinstatement of his license Mr. Krug must enter into a contract with the Winners Foundation prior to November 14, 2007, and abide by the terms and conditions of that contract. Further, conditions of testing are placed on Mr. Krug's license through the term of his license. Failure to comply with the terms of probation may result in the suspension of Mr. Krug's license privileges.

During the term of this suspension all licenses and license privileges of Erik Alan Krug are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises within this jurisdiction.

LOVELACE RULING

Pony rider SHONDRA LEE LOVELACE failed to appear yesterday to address case 07PM018, which alleged violation of CHRB rule 1498 (h) (Grounds for Denial of Refusal

of License). This case involved allegations of methamphetamine use and drug paraphernalia possession. The following ruling was issued:

HRTH #05

Board

Pony Rider SHONDRA LEE LOVELACE having failed to respond to written notice to appear before the Board of Stewards at Hollywood Park on or before November 10, 2007, to answer charges alleging violation California Horse Racing Board rule #1489 (h) (Grounds for Denial or Refusal of License) is hereby suspended pending an appearance before a Board of Stewards for violation of California Horse Racing rule #1547 (Failure to Appear).

During the term of this suspension all licenses and license privileges of Shondra Lee Lovelace are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises within this jurisdiction.

Groom JULIO CESAR VARGAS SOSA (license 255985) met with the Stewards as required by a violation notice from Santa Anita Park security. Mr. Sosa was cited for not displaying a CHRB license. The Stewards issued a warning.

INQUIRY/NO DISQUALIFICATION

Take

The Stewards posted the inquiry sign following the running of the sixth race on Sunday to examine an incident in the stretch, in which one horse fell and two horses lost their riders. Shortly after straightening out in the stretch, #3 Stretchin the Take, ridden by Fernando Jara, clipped heels with #6 Dr. Zaentz and fell, unseating Mr. Jara. #5 Dewey's Special attempted to jump the fallen horse and managed to stay on his feet but unseated rider Jose Valdivia. After speaking with jockey Garrett Gomez and the Patrol Judges, as well as reviewing the films, the Stewards determined that the eventual winner, #11 Dee Dee's Legacy, and #3 Stretching the Take both angled for the same spot. As #3 Stretchin the then attempted to correct his path, he overcorrected and drifted out over the heels of another rival. Given the fact that there were several contributing factors to the incident and that no blame could be solely attached to a particular runner, the Stewards elected to make no change to the original order of finish.
