RULING NO. 1 – SPIKES RULING

Jockey **SHAWN SPIKES** who rode **STEEL PLANK** in the eighth race at the Sonoma County Fair on Sunday, August 12, 2018 is fined the sum of One Hundred Dollars (\$100.00)* for violation of California Horse Racing Board rule #1688 (4) (Use of Riding Crop – Used more than three consecutive times without giving the horse a chance to respond).

The above ruling was issued after Mr. Spikes came in and accepted the penalty.

08-16-18² **TOTE FAILURE**

Mutuel Manager Doug Gooby reported that a technical failure caused by Robert Communication resulted in a 45 minute delay in the opening of wagering on track.

08-16-18³ **RACE 4 – INQUIRY – NON-STARTER DECLARED**

The inquiry sign was posted to review the start concerning 3-5 favorite #6 HE’S A TIGER (Hugo Herrera). As the field was dispatched from the gate by starter Randy Cope #6 HE’S A TIGER whipped its head over to the right and over the starting gate bar which did not allow him to break with the field. #6 was declared a non-starter in a unanimous decision for failure to be afforded a fair start. REFUND: \$22,196.46.

08-16-18⁴ **RACE 5 – INQUIRY – NO CHANGE**

The inquiry sign was posted to review the start of #6 MARK YE WELL (Jesus Velazquez). #6 was a bit fractious in the gate and then settled down. Starter Cope dispatched the field and #6 reared causing jockey Velazquez to step off in the gate. The gate opened properly and #6 was afforded a fair start. No change.

#1 BIZMO left the starting gate without his rider Shawn Spikes. #1 had been acting up a little bit in the gate and Spikes had stepped back onto the pontoons of the gate. Starter Randy Cope missed the fact that Spikes was off the mule and dispatched the field. #1 was declared a non-starter.

To make the race even more eventful #3 OKIE MOUSE started bucking about 100 yards out of the gate and unseated jockey Chester Bonnet. This resulted in only three mules finishing the race.

Starter Randy Cope will visit with the stewards in the morning. REFUND: \$12,696.28.

Starter **RANDALL COPE** is fined the sum of Two Hundred Dollars (\$200.00)* pursuant to California Horse Racing Board rule #1552 (Duties of the Starter) for violation of California Horse Racing Board rule #1696 (b) (The Start – did not receive a fair start causing a mule to be declared a non-starter in the first race at the Humboldt County Fair on August 17, 2018).

The above ruling was issued after Cope appeared and accepted responsibility for dispatching the first race field without a jockey on post time favorite BIZMO.
