Report of the Board of Stewards for the week of July 3, 2014 through July 6, 2014.

THURSDAY

07/03/2014 (1) DUTY STEWARD

Scott Chaney will be on duty this week attending to scratches during this reporting period.

(3) MEETING WITH RIDER

The Stewards met with jockey Eswan Flores this morning to discuss the results of the test sample he submitted this past Sunday. (Ref. 6-29-14-7) Quest Laboratory reported that the sample contained Xanax, an anxiety medication, in a quantity well above the cut off point for a positive. With Mr. Flores was R.C. Ebanks, who will be Flores' agent. He explained that Eswan has not used the medication in four days and will be using holistic methods to cope with his problems. The rider will test on Sunday to see if his system is free of the drug.

(4) PEREZ RULING

Jockey Fernando Perez- LATL #01

JOCKEY FERNANDO PEREZ WHO RODE "AMNESIA (IRE)" IN THE SIXTH RACE AT SANTA ANITA PARK ON THURSDAY, JUNE 29, 2014, IS SUSPENDED THREE (3) RACING DAYS (JULY 6TH, 10TH AND 11TH, 2014) FOR CROSSING OVER WITHOUT SUFFICIENT CLEARANCE, CAUSING INTERFERENCE WHICH RESULTED IN THE DISQUALIFICATION OF HIS MOUNT FROM FIFTH TO UNPLACED. THIS CONSTITUTES A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES-CARELESS RIDING). PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE 1766 (DESIGNATED RACES), THE TERM OF SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES.

This ruling was issued after Mr. Perez viewed video of the sixth race from 6-29, in which his mount was disqualified for interference entering the first turn. (Ref. 6-29-24-9) Mr. Perez was candid, offering little in the way of an excuse for his actions.

(5) GOMEZ RULING

Trainer Ruben Gomez- Ruling #002

TRAINER RUBEN GOMEZ IS FINED FOUR HUNDRED DOLLARS (\$400.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1437 (CONDITIONS OF A RACE MEETING-INSUFFICIENT WORKS ON July 3, 2014).

This ruling was issued as Mr. Gomez' horse, Storm Hollow, was declared this morning as it was over 30 days since its last work. Mr. Gomez said that the owners entered the horse without informing him.

(6) JOCKEY MEETING

The Stewards met with the jockey colony prior to the first race to explain our expectations for this meet. We stressed that with the unusual configuration of the race course riders had to work together to maintain a safe riding environment. Almost all of the riders in attendance had ridden at Santa Anita and were familiar with protocol.

(7) TRACK OBSERVATION

The Stewards, along with Safety Stewards Luis Jauregui, took a trip to the backstretch to look at the inside rail, which "bellys out" near the four and one half furlong pole. Riders on the outside of a field will have to give ground in order to maintain safety.

(8) RULING

A refund was ordered in the sixth race as #5, Time for a Hug, did not warm up to the satisfaction of Racing Veterinarian Stead and was declared on his recommendation. The refund amounted to \$18,104.00.

(2) COUTON VIDEO REVIEW

Jockey Julian Couton was in the office this morning to review the eighth race from Thursday, as his mount was responsible for interference entering the far turn. The rider said he reacted as quickly as he could to mitigate the interference and he also did not feel the rider who had to take up, Modesto Linares aboard #8 Honky Tonk Diva, should have attempted to drive into the hole at the point of the turn. We agreed with Mr. Couton on both points and he left with an admonishment to be more alert when negotiating the turn.

(2) VIDEO REVIEW

Jockey Brice Blanc was in the office this morning to review the fourth race from Friday as the Stewards were concerned about his use of the whip during the stretch run. Mr. Blanc's mount was running in last position and he struck the horse six times—albeit lightly—from the 3/16th pole to the 1/16th marker. When asked why he used his whip, the rider said the horse was a first-time-starter and he wanted the colt to keep its mind on the race. He apologized for his actions and assured us it would not happen again. Mr. Blanc left with a warning, but was told a similar occurrence would result in a stringent sanction.

(3) LATE RIDER CHANGE

A late rider switch was announced in the fourth race as jockey Gary Boag, scheduled to ride #5 Storm Bid, did not arrive in time to fulfill his engagement. A replacement rider was named.

Jockey Felipe Martinez was in the office to view the ninth race from Saturday as a rider to his inside took up sharply entering the far turn. After reviewing the race and discussing the situation with Mr. Martinez, it was agreed that a combination of factors resulted in Tyler Baze, aboard #4 Star Rising, having to check. While Mr. Martinez' mount did drop in at the point of the turn, it was clearly evident that Mr. Baze never should have attempted to drive between horses at that juncture. A warning was issued.

(3) IMPRESSIVE PERFORMANCE

Tyro Drayden Van Dyke, one of the leading candidates for the Eclipse Award for Apprentice Jockey, turned in a "four bagger" this afternoon, winning the first four races. He finished second with his other two mounts.
