JOCKEY FILM REVIEW

Felipe Valdez met with the Stewards to review the fourth race on Friday. Mr. Valdez was asked about his ride in which he didn't use the whip and he was beaten a head for second place. Trainer Jorge Gutierrez stated his riding instructions were to keep the horse gathered and to not over ride and that he was pleased with the ride given. Mr. Valdez stated when he last worked the horse in the AM; the horse did not respond from the whip and slowed down when it was used. The BOS felt this explanation for the ride was acceptable. Mr. Gutierrez was told if he does not want a whip used in a race, to declare no whip at the time of entry. He said he would do so.

Edwin Maldonado and Martin Garcia met with the Stewards to review the second race (ref 12-05-15⁵) that involved an inquiry in the stretch run. Late in the stretch #2 Ossetra (M. Garcia) drifted in, brushing the horse to its inside, #3 Glory Bound (E. Maldonado 3rd) causing this one to change leads, shift into the path of the #1 Go Long (K. Desormeaux 5th) causing that one to alter course. Neither Mr. Garcia nor Mr. Maldonado were blamed for the horses' actions and left with a warning.

Edwin Maldonado also represented Martin Pedroza for the review of the third race yesterday (ref 12-05-15⁶) in which his mount was disqualified from third and placed fourth. The incident occurred folding into the turn at the 3/8 pole. Mr. Pedroza on the outside of a three horse spread, then dropped in when the horse changed leads going into the turn. First in, #2 Rebarules (T. Baze 5th) was trying to get out and changed leads late into the turn adding to the incident. The majority felt if #2 had changed leads sooner there would have been enough room for the horse in the middle, #4 Sharpest One (C. Aragon 4th) to hold its position, therefore relieving Mr. Pedroza of total responsibility. Judge Chaney did not agree with the assessment and felt a three day suspension was in order.

LWTL #004

Jockey MARTIN GARCIA is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond - first offense in the last sixty days), during the second race at Los Alamitos Race Course on December 6, 2015.

12/10/15²**PANICUCCI RULING**

The following ruling was issued after Mr. Panicucci met with the Stewards to discuss the citation issued to him for crossing the 3/4 chute between 7:45 and 8:00 during morning training hours at Santa Anita. This is not allowed due to starting gate workouts. He felt the penalty was not deserved because he only crossed half way. His assumption was wrong.

LWTL #005

Apprentice jockey BRUNO PANICUCCI is fined FIFTY DOLLARS (\$50.00)* for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – pulling up in front of starting gate in contradiction of track safety rules).

Apprentice David Lopez and Fernando Perez met with the Stewards to review the fourth race yesterday. In the mile event, Mr. Lopez drifted out several paths in the stretch run and made contact with Mr. Perez to his outside. Mr. Perez's horse in late stretch changed to its left lead, and ducked in front of Mr. Lopez from a strong right handed whip. Neither infraction was penalty worthy but they were warned they need to be more aware and make better efforts to correct in the future. They both agreed to do so.

12/11/15²**ACCIDENT SEVENTH RACE**

As the field crossed the finish line, #4 Giant's Lexis (last) went wrong, fell and unseated jockey Felipe Valdez. Racing Veterinarian Dana Stead and the EMTs were on scene immediately. The horse was ambulance removed and was euthanized. Mr. Valdez was transferred to the paramedics and transported to Long Beach Memorial. Accident and Notification reports attached.

Jockey GARY BOAG is fined ONE HUNDRED DOLLARS (\$100.00)* for failure to arrive at the Jockeys' Room at the proper time, resulting in his failure to fulfill his riding engagement in the eighth race at Los Alamitos Race Track on December 11, 2015. This constitutes a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey agreement).
