PEREIRA RULING

The following ruling was issued after confirmation was received that the appeal had been dropped.

RULING LWTL #013

Having received notice from the California Horse Racing Board that the appeal of LATC ruling #010 (October 6, 2017) has been withdrawn, the original ruling is reinstated. Jockey TIAGO PEREIRA is suspended for THREE (3) racing days (December 26, 29 and 30, 2017).

BOULANGER RULING

The following ruling was issued after MR. BOULANGER was informed of the penalty. He had no plausible excuse for his tardiness to the paddock.

RULING LWTL # 014

Pursuant to California Horse Racing Board rule #1530 (Cases Not Covered By Rules And Regulations) jockey BRANDON BOULANGER is fined FIFTY DOLLARS (\$50.00)* for being late to the walking ring for the sixth race at Los Alamitos Race Course on December 10, 2017.

JOCKEY FILM REVIEW

Matt Garcia met with the Stewards to review the first race on Sunday involving a Stewards' inquiry. Approaching the half mile marker in the 5 1/2 furlong event Mr. Garcia aboard the #1 horse drifted out without an effort to correct, causing the horses to

his outside to check and take up. In a unanimous decision Mr. Garcia received a three day penalty listed in the ruling below for careless riding.

RULING LWTL # 015

Jockey MATT GARCIA, who rode "RAFTER ONE" in the first race on December 10, 2017, is suspended for THREE (3) racing days (December 26, 29 and 30, 2017) for altering course without sufficient clearance, causing interference on the backstretch. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules). Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

JOCKEY FILM REVIEW

MATT GARCIA met with the Stewards to review the seventh race yesterday in which he violated the crop rule. MR. GARCIA admitted he failed to comply with the rule. The following ruling was issued.

RULING LWTL #016

Jockey MATT GARCIA is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond - first offense within the previous sixty day period), during the seventh race at Los Alamitos Race Course on December 14, 2017.

12/15//17²**RODRIGUEZ FORMAL HEARING CASE #17LT0032**

The CHRB filed a complaint against trainer VICTOR RODRIGUEZ for violation of CHRB rules 1843 (a)(d) (Medications, Drugs and Other Substances), 1844 (c)(1)(Authorized Medication), 1866 (d)(Veterinarian's List) and 1887 (a)(Trainer to Insure Condition of horse). MR. RODRIGUEZ worked his horse to be removed from the Veterinarian's List on September 7, 2017. The official blood sample contained 2.82 ug/ml of phenylbutazone (authorized level 2.0). MR. RODRIGUEZ explained there was a mistake at his barn and the horse received the medication within 24 hours of the workout. MR. RODRIGUEZ'S unblemished record made him eligible for and he received an official warning.

12/15/17³**VOIDED CLAIM**

After an examination by Official Veterinarian Debra Lamparter of #1 in the SOPHIA DEL SOL in the first race the horse was placed on the Veterinarian's List and the Stewards voided the claim. The horse returned to the stable of trainer Steve Sherman.

SATURDAY12/16/17¹**NAKATANI RULING**

After the adoption of the Proposed Decision by the California Horse Racing Board, the decision was remanded to the BOS to issue the following ruling.

RULING LWTL #017

Having received notice from the California Horse Racing Board that the proposed decision regarding the appeal of DMTD ruling #051, dated August 20, 2017, has been adopted in part, jockey COREY NAKATANI is suspended for THREE (3) racing days (December 30, 31, 2017 and January 1, 2018). Pursuant to California Horse Racing Board rule #1766 (designated races), the term of suspension shall not prohibit participation in designated races.

12/16//17²**SOTO HEARING CASE 17LT0037**

The CHRB filed a financial complaint (1876-Financial Responsibility) against trainer ANTONIO SOTO for a debt owed to Finish Line Self Insurance Group, Inc. in the amount of \$19,244.85. MR. SOTO was present and Finish Line representative Allie Rodriguez was available by telephone. It was noted that Ms. Rodriguez's copy of the billing in the

complaint packet, except for the last entry was outside the one year deadline to file a financial complaint, CHRB rule 1876 (b). MR. SOTO acknowledged he owes the majority of the debt, but argued trainer Jesus Nunez was responsible for a large portion. The following ruling was issued after all accounts were taken into consideration.

RULING LWTL #018

Trainer/Owner ANTONIO SOTO is ordered to pay Finish Line Self Insurance Group TEN THOUSAND DOLLARS (\$10,000.00) on or before February 1, 2018. Failure to comply with this ruling will constitute a violation of California Horse Racing Board rule #1876 (Financial Responsibility).

ELLIS RULING

Upon adoption of the proposed decision by the California Horse Racing Board, it was remanded back to the BOS to issue the following ruling.

RULING LWTL #019

Acting on an order of remand following the adoption of the decision by the California Horse Racing Board, trainer RONALD ELLIS, trainer of the horse MASOCHISTIC, the second place finisher in the sixth race (Breeders' Cup Sprint) at Santa Anita Park on November 5, 2016 is fined TEN THOUSAND DOLLARS (\$10,000.00)* and suspended for SIXTY (60) DAYS (January 1, 2018 through March 1, 2018) pursuant to California Horse Racing Board rule #1887(a) (Trainer To Insure Condition Of Horse), for violation of California Horse Racing Board rule #1843(a)(d) (Medication, Drugs And Other Substances), #1843.1(b) (Prohibited Drug Substances – presence of stanozolol in the blood and urine– [Class III – Category “B” penalty]). In accordance with rule #1843.3(k)(1) (Penalties For Medication Violations), RONALD ELLIS shall forfeit all assigned stall space and shall remove from the enclosures all signage, colors, advertisements, training-related equipment, tack, office equipment and any other property during his suspension. RONALD ELLIS shall not

transfer any horses to licensed family members or any other licensee who has been an employee of his within the previous year.

During the term of suspension, all licenses and license privileges of RONALD ELLIS are suspended, RONALD ELLIS is prohibited from entering horses during the term of suspension, and pursuant to California Horse Racing Board rule #1528 (Jurisdiction Of Stewards To Suspend Or Fine), RONALD ELLIS is denied access to all premises in this jurisdiction.

JOCKEY FILM REVIEW

BRYAN PENA met with the Stewards to review the use of his crop in the fourth race. MR. PENA has acquired a style of a long slow flag of the crop between strikes to allow for two strides needed to comply, he was cautioned if he is going to hit repeatedly he has to allow more time before using the crop again, warning. Steward Jauregui voted for a penalty.

JUAN SANCHEZ also met with the Stewards to review his ride in the third race in which it appeared MR. SANCHEZ may have stood up early costing his mount a better placing, a nose for third position. After a review of the race, unanimously the BOS felt a warning was warranted due to the lack of evidence on the videos available.
