07/06/18²**RULING LATL #003**

Jockey ALONSO QUINONEZ is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the eighth race at Los Alamitos Race Track on July 4, 2018.

This ruling was issued as Mr. Quinonez did not offer an excuse for violating the “crop” rule.

07/06/18³**RULING LATL #004**

Owner ERIC SMITH, having complied with the provisions of California Horse Racing Board rule #1876 (Financial Responsibility – agreement with BG Thoroughbred Farm for \$36,451.82) is restored to good standing. Ruling LATS #214 issued at Santa Anita Park on June 24, 2018, is set aside.

The preceding ruling was issued as an agreement between Mr. Smith and B G Thoroughbred Farm was finalized and signed. His horse will now be permitted to start in the second race on the afternoon card.

07/06/18⁴**LATE DECLARATION – “SHOW” WAGERING CANCELED**

#5 GAYEBIRD was a late declaration from the first race as it became fractious while entering the track and injured the rider, Christian Aragon. A decision was made to scratch the horse as it was felt that bringing the field back to the paddock while a substitute rider was found would be unfair to the remainder of the field. The scratch reduced the field to four interests and prompted the cancelation of the “Show” pool. The refund amounted to \$164,194.99.

07/06/18⁵**RACING CARD CANCELED DUE TO EXTREME HEAT**

Following the second race we received a call from Jockeys Guild manager Darrel Haire, who was located in the Jockeys’ Room. He reported that the riders were extremely concerned about the temperature and did not feel that it was safe to continue the card. Members of the management team were summoned to the Jockeys’ Room and after a brief meeting with the riders the decision was made to cancel the remaining six races. Announcements were made as to pari-mutuel payoffs and refunds on the multi-race wagers. The temperature at Los Alamitos at the time of cancelation was 107 degrees.

Jockey ISRAEL OCAMPO was excused from his lone mount of the day due to illness. A replacement was named. Jockey CHRISTIAN ARAGON, who was injured in a post parade accident yesterday, was forced to take off this afternoon as he has not recovered from his injury. Replacement riders were announced.

ACCIDENT - STEWARDS' INQUIRY INTO START – HORSES DECLARED STARTERS

The inquiry sign was posted after the ninth race as the Stewards took a look at two incidents which happened in the first ten yards of the five furlong event. As the stall doors opened, #7 RAMONA LOVER, with Tiago Pereira aboard, went in the air and was off several lengths behind the field. Moments later, #6 ALL NET, the 3/2 favorite ridden by Martin Pedroza, grabbed a quarter and stumbled sharply, leading to Pedroza being unseated. It should be noted that Pereira made an excellent effort to avoid his fallen comrade as he deftly maneuvered his mount away from Pedroza. We understand that no injuries occurred.

The claim of the horse All Net from the ninth race this afternoon was voided as the horse was “off” in the right foreleg during its time in the detention barn. It was returned to the barn of trainer David Jacobson.

MEDICATION HEARING

Trainer MATTHEW CHEW, who was accompanied by his assistant, Darryl Bond, was in the office this morning for a formal hearing to address a complaint filed against him for a double NSAID – 0.74ug/ml of Phenylbutazone and 11.3ng/ml of Flunixin – found in his horse Topaz Time, the winner of the second race at Santa Anita Park on May 25, 2018.

Mr. Chew and his assistant both testified that they followed the same regimen as always – Flunixin paste forty eight hours prior to race day and Phenylbutazone twenty four hours out. Security footage confirmed their statements. Mr. Chew was at a loss to explain the findings in the sample as he said he was confident that his barn did not make a mistake. With respect to the nebulizer treatment on race day, he said that he was unaware of the prohibition since the treatment did not contain any “medication”, only pink Himalayan sea salt. He said he has used the product for several years as it cleanses the lungs and also reduces inflammation. He indicated that there is very poor air quality in his barn and has had to resort to the nebulizer treatment. A decision will be rendered shortly.
