JOCKEY JAIRO RANGEL IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (B)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-THIRD OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE RUNNING OF THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON JULY 3, 2020.

Ruling #149

JOCKEY JAIRO RANGEL, IS SUSPENDED FOR THREE (3) RACING DAYS (JULY 12th, 17th, AND 18th, 2020) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FOURTH OFFENSE WITHIN THE PAST 60 DAYS) DURING THE FIFTH RACE AT LOS ALAMITOS RACE COURSE ON JULY 3, 2020.

Ruling #150

JOCKEY CRUZ MENDEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FIRST OFFENSE WITHIN THE PAST 60 DAY PERIOD), DURING THE RUNNING OF THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON JULY 3, 2020.

Ruling #151

JOCKEY JUAN PABLO LEON IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FIRST OFFENSE WITHIN THE PAST 60 DAY PERIOD), DURING THE RUNNING OF THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON JULY 3, 2020.
