(4) ARANA RULINGRULING # 201

GROOM FREDI CHAVEZ ARANA IS FINED TWENTY FIVE DOLLARS (\$25.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS) ON WEDNESDAY, SEPTEMBER 12, 2007.

The above ruling was issued after speaking with groom Arana about his erratic driving in the barn area. He was told to refrain from driving in the stable area in the future.

(5) LUNA RULINGRULING # 202

JOCKEY ALEJANDRO LUNA IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT) ON SUNDAY, SEPTEMBER 9, 2007.

The above ruling was issued after meeting with jockey Alejandro Luna concerning his failure to contact the Stewards for permission to come in late and then failing to arrive in time to fulfill his commitments. He assured us it wouldn't happen again.

(6) NAVARRO RULINGRULING # 203

JOCKEY VICTOR NAVARRO WHO RODE "BRANDI'S STARLITE" IN THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, SEPTEMBER 9, 2007, IS SUSPENDED FOUR (4) RACING DAYS (SEPTEMBER 20TH, 21ST, 22ND, AND 23RD, 2007) FOR FAILURE TO MAKE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE, RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FIRST TO THIRD POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

Citing a late race commitment in Pomona Victor Navarro was represented by jockey Alejandro Luna this evening. After reviewing the race in question Alejandro agreed that Victor could have made more of an effort prompting the above ruling.

(7) ACEVES RULINGRULING # 204

JOCKEY NORBERTO ACEVES IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1530 (CASES NOT COVERED BY RULES AND REGULATIONS) FOR UNPROFESSIONAL CONDUCT – POST RACE ON SUNDAY, SEPTEMBER 9, 2007.

The above ruling was issued following an informal hearing with jockey Norberto Aceves. Jockey Aceves acted in an unprofessional manner after dismounting following the first race.

(4) JOCKEYS VISIT

The riders were in this evening escorted by Darrell Haire, Terry Meyocks, the new National Managing Director of the Jockey's Guild and Jeff Johnston, a new Regional Manager. Both the riders and the Stewards felt the meeting was very productive. The riders felt that even though our meetings are in their infancy they have already had an effect on their race riding.

OWNER RALPH HAWKINS, HAVING RECEIVED NOTICE, AND HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 15, 2007 TO ANSWER A COMPLAINT REGARDING CASE # 07LA0170, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PENDING APPEARANCE BEFORE THE BOARD OF STEWARDS PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1547 (FAILURE TO APPEAR).

DURING THE TERM OF THE SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF RALPH HAWKINS ARE SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE). SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION

The above ruling was issued when Mr. Hawkins failed to appear after being ordered to do so by this Board of Stewards.

(4) FILMS

Jockey Jimmy Vail was in to watch last night's eighth race, a Quarter Horse race going 870 yards. Jim won the race but allowed his mount to drift throughout the stretch run. The outcome was never in jeopardy but we felt he could have shown a little more effort to keep his mount straight.

(5) FILMS

Jockey Carlos Huerta was in to review the first race last night. It appeared he began to ease his mount up prior to the finish line. He was told that in the future he would be expected to ride his mounts out to the wire.

(6) FILMS

Jockey Juan Andrade was by to review the tenth race last night evening. His mount drifted out during most of the race and although there was obvious effort made on his part we felt it was a bit less than what we would expect of him.

(7) FILMS

Jockey Eulices Gomez was in to review the third race last evening. His mount broke out bumping the horse next to him. He explained that his leg got tangled with Victor Navarro's and as soon as he was able to extricate himself he pulled his horse off Victor's. The explanation sounded plausible to us after watching the rerun.
