(1) DUTY STEWARD

Nine races were drawn for Sunday's program. One Arabian, one Thoroughbred and seven Quarter Horse races make up the card.

(3) CAL-BRED REPORT

The CAL-BRED race for today failed to fill.

(4) RAMIREZ III RULINGRULING # 214

HAVING SATISFIED A DEBT TO EDWIN SIRIN, OWNER SAUL RAMIREZ III IS HEREBY RESTORED TO GOOD STANDING. RULING # 211 ISSUED AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 22, 2007, FOR FAILURE TO APPEAR, IS HEREBY SET ASIDE.

The above ruling was issued when Mr. Ramirez settled a financial problem.

(5) SIRIN RULINGRULING # 215

OWNER EDWIN SIRIN IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1580 (CONTROL OVER ENTRIES AND DECLARATIONS) ON SUNDAY, SEPTEMBER 23, 2007.

The above ruling was agreed upon after Mr. Sirin's horse was entered at Pomona and Los Alamitos on the same day.

(6) JOCKEY REVIEWS REPLAY

Jockey Juan Andrade appeared, accompanied by his interpreter jockey Guillermo Gutierrez, to review Sunday's first race with the Stewards. The rider was cautioned to lay down his whip and pay more attention in keeping his horse straight.

(7) BAUTISTA RULINGRULING # 216

JOCKEY ALEX BAUTISTA WHO RODE "CORONA WILD DASH" IN THE TENTH RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, SEPTEMBER 22, 2007, IS SUSPENDED FOUR (4) RACING DAYS (OCTOBER 4TH, 5TH, 6TH, AND 7TH, 2007) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE, RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM THIRD TO NINTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The above ruling was issued after Mr. Bautista reviewed last Saturday's tenth race with the Stewards. The Stewards are of the opinion the rider could have made a better effort in correcting his mount leaving the gate.

(2) CAL-BRED REPORT

The fifth race in the book for three year olds, claiming price \$2,500, going 300 yards, failed to fill.

(3) BOCANEGRA RULINGRULING # 217

HAVING SATISFIED A DEBT TO EDWIN SIRIN, OWNER GONZALO BOCANEGRA IS HEREBY RESTORED TO GOOD STANDING. RULING # 212 ISSUED AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 23, 2007, FOR FAILURE TO APPEAR, IS HEREBY SET ASIDE.

This ruling was issued after respondent brought in \$470 to satisfy a debt to T&R Tack.

(4) JOCKEY'S MEETING

Jockey's Guild Western Regional Manager Darrell Haire, and ten to twelve jockeys appeared for the weekly meeting of film review. Four races were replayed and discussed thoroughly, with all present participating.

(5) STEWARDS INQUIRY - DISQUALIFICATION

After the finish of the third race (Quarter Horse – 300 yards) the Stewards posted the Inquiry sign to review the start. Involved were the fourth place finisher # 1 "Ez Honor" (jockey Saul Ramirez, Jr.) and the last place horse # 2 "Wild California Rose" (jockey Alex Bautista). After talking with the riders involved and reviewing the replays the Stewards unanimously agreed to disqualify # 1 from fourth and place her last, behind # 2, for interference at the start. Replays show # 1 break out sharply at the start, bumping # 2, costing the latter any chance in the race.

Eight races were drawn for next Thursday's program. One Thoroughbred, and seven Quarter Horse races complete the card.

(2) CAL-BRED REPORT

The third race in the book for two years old, claiming price \$8,000, going 300 yards, failed to attract an entry.

(3) STEWARDS INQUIRY – DISQUALIFICATION

After the finish of the second race (Quarter Horse – 300 yards), the Stewards posted the inquiry sign to review an incident nearing the wire. Involved were the second place finisher # 9 "Super Social" (jockey Norberto Aceves), the third place finisher # 7 "Shake Em Fast" (jockey Alex Bautista), and the fourth place horse # 8 "Vf Streakin Back" (jockey Rodrigo Aceves). After talking with the riders involved, and reviewing the tape replays the Stewards unanimously agreed to disqualify # 9 from second and place him fourth, behind # 8, for interference to both # 7 and # 8, approaching the wire. Replays show # 9, on the outside, veer inwards, causing # 8 to take up and be forced in, bumping # 7 on his inside, costing the latter pair the opportunity at better placings.

The fifth race in the book for maidens three years old and upward, going 300 yards, was called off with three entries.

JOCKEY NORBERTO ACEVES WHO RODE "SUPER SOCIAL" IN THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, SEPTEMBER 29, 2007, IS SUSPENDED FOUR (4) RACING DAYS (OCTOBER 7TH, 11TH, 12TH, AND 13TH, 2007) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE, RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM SECOND TO FOURTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The above ruling was agreed upon after Jockeys Guild Representative Cody Jensen reviewed replays at last evening's second race with the Stewards. Jockey Jensen represented Norberto Aceves, who was not available, and explained the horse that was disqualified was difficult to ride. However, the Stewards are of the opinion Mr. Aceves could of prevented the incident.
