11/20/2007

(1) DUTY STEWARD

(1) CAL-BRED REPORT

The sixth race in the book, for Cal-Breds three-year-old fillies going 300 yards for a claiming price of \$5,000, failed to fill with one entry.

(2) THE DRAW

Eight races were drawn for Thursday's card. There will be three Thoroughbred races, and five Quarter Horse races.

(3) PAGANO RULING # 253

The following ruling was issued after an error in the complaint was discovered:

RULING # 253

OWNER MICHAEL PAGANO, HAVING BEEN SUSPENDED DUE TO ADMINISTRATIVE ERROR, IS HEREBY REINSTATED AND RESTORED TO GOOD STANDING. RULING # 246 ISSUED NOVEMBER 9, 2007 IS HEREBY SET ASIDE.

(4) BLOOMQUIST RULING # 254

After consideration of evidence offered, the following ruling was issued:

RULING # 254

TRAINER CHARLES E. BLOOMQUIST WHO STARTED THE HORSE "SHOSONE" IN THE THIRD RACE ON OCTOBER 7, 2007, AT LOS ALAMITOS RACE COURSE IS FINED FOUR HUNDRED DOLLARS (\$400.00)\* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1843 (A&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES – TWO NSAIDS PHENYLBUTAZONE AND FLUNIXIN, NOT IN EXCESS OF PERMITTED LEVEL).

(5) WILLOUGHBY HEARING

Trainer Scott Willoughby appeared on a complaint alleging an excess of bute. Mr. Willoughby could not explain the excess finding. However, he took full responsibility for the violation.

RULING # 255

TRAINER SCOTT WILLOUGHBY WHO STARTED THE HORSE "THINKING FIRST" IN THE SEVENTH RACE AT LOS ALAMITOS RACE COURSE ON OCTOBER 19, 2007, IS FINED FOUR HUNDRED DOLLARS (\$400.00)\* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1843 (A&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES – PHENYLBUTAZONE IN EXCESS OF PERMITTED LEVEL – FIRST OFFENSE IN A TWELVE MONTH PERIOD).

(6) CIRO VILLEGAS HEARING

Groom Ciro Villegas appeared to answer a violation notice for disorderly conduct. Mr. Villegas allegedly was rude and offensive when contacted by security.

Mr. Villegas apologized for his behavior. In light of his long-term employment at Los Alamitos, he was warned that another episode would most likely lead to his expulsion from the grounds. Mr. Villegas was placed on probation for the term of his license.

(7) DOROTHY WILLIAMS HEARING

Jockey Dorothy Williams appeared to review her ride on # 6 "Power to Wow" on Sunday, November 18, 2007. "Power to Wow" was disqualified from third to fourth in Sunday's Race 8 because he lugged out dramatically under left handed whipping, and bumped # 7 "Deb's Boot" causing # 7 to lose stride, ground, and position.

Ms. Williams accepted her penalty and admitted culpability for the incident.

(8) SATURDAYS RACES

Saturday's card included three Divisions of Z Wayne Griffin Directors Trials, G III, and was concluded without major incident.

**SUNDAY**  
11/25/2007(1) INQUIRY RACE 6 – DISQUALIFICATION

While crossing the gap # 2 "Chickabono", ridden by jockey Jay Conklin lugged in, striking # 1 "Beduino's Escape", ridden by Cesar De Alba. The bump # 2 inflicted on # 1 cost # 1 stride, ground, and position. Because the contact cost # 1 the opportunity for a better placing, # 2 was disqualified from 5<sup>th</sup>, and placed last, behind # 1.

Order of Finish after DQ: 5 – 3 – 6 – 4 – 7 – 1 – (2)

(2) RACE 10 APPARENT BREAKDOWN

Before passing the 1/16<sup>th</sup> pole, # 5 "Special Misterio", ridden by J.R. Ramirez, went wrong in a hind leg, and was pulled up. It was later determined that the horse's stifle locked up.
